ORDINANCE NO. 17214

AN ORDINANCE Altering, defining and establishing the names of certain streets, avenues, ways and places in that certain portion of the City of Seattle heretofore lying within the limits of the City of West Seattle.

BE IT ORDAINED BY THE CITY OF SEATTLE, AS FOLLOWS:

Section 1. That the names of certain streets, avenues, ways and places hereinafter mentioned, now platted or existing in that certain portion of the City of Seattle heretofore lying within the limits of the City of West Seattle, be and the same are hereby altered, defined and established as follows, to-wit:

(39) That Cambridge Avenue in The Boston Company's Plat, and in Norris' and Ashford Additions, be Thirty-eighth Avenue Southwest.

(40) That Canyon Avenue in Seashore Park Addition, be Canyon Drive.

(41) That Carden Street in Union Pacific Addition, be West Ferdinand Street.

(42) That Carolina Street in Plat of Seattle Tide Lands, be Bronson Way.
