ORDINANCE FO. 21630

AN ORDINANCE Providing for the laying off, widening, altering and establishing of Grand Street, from the west margin of Fourteenth Avenue South (from the north) to the east margin of Twenty-second Avenue South (from the north); and from the east margin of Twenty-fifth Avenue South (from the south) to the east margin of Twenty-eighth Avenue South (from the south), all in the City of Seattle; and providing for the condemnation, appropriation, taking and damaging of land and other property necessary therefor; and providing that the payment for such improvement be made by special assessment upon property specially benefited, in the manner provided by law.

WHEREAS, Public necessity and convenience demand that Grand Street, as hereinabove designated, be laid off, widened, altered and established as a public street and highway; and

WHEREAS, Said improvement will be of special benefit to certain lands, premises and other property; NOW, THEREFORE:

BE IT ORDAINED BY THE CITY OF SEATTLE, AS FOLLOWS:

SECTION 1. That Grand Street, from the west margin of Fourteenth Avenue South (from the north) to the east margin of Twenty-second Avenue South (from the north); and from the east margin of Twenty-fifth Avenue South (from the south) to the east margin of Twenty-eighth Avenue South (from the south), all in the City of Seattle, be and the same is hereby laid off, widened, altered and established as a public street and highway over and across certain lots, blocks and tracts of land in said city, more particularly described as follows, to-wit:

IN J. C. KINNEAR'S ADDITION TO THE CITY OF SEATTLE.

That portion of lot four (4), block five (5), described as follows, to-wit: Beginning at a point on the north line of said lot, said point being distant one hundred and eighteen one-hundredths (100.18) feet east from the northwest corner of said lot; thence east along the north line thereof a distance of nineteen and eighty-two one-hundredths (19.82) feet to the northeast corner of said lot; hence south along the east line thereof a distance of sixty (60) feet to the southeast corner of said lot; thence west along the south line there-of a distance of one and forty-four one-hundredths (1.44) feet;

That portion of lot four (4), block six (6), described as follows, to-wit: Beginning at a point on the east line of said lot, said point being distant fifty and four one-hundredths (50.04) feet north from the southeast corner of said lot; thence north along the east line thereof a distance of nine and ninety-six one-hundredths (9.96) feet to the northeast corner of said lot; thence west along the north line thereof a distance of nine and ninety-six one-hundredths (9.96) feet; thence southeasterly along the arc of a curve to the right having a uniform radius of ten (10) feet, a distance of fifteen and sixty-seven one-hundredths (15.67) feet, to the point of beginning.

SECTION 4. That the Corporation Counsel be, and he is hereby, authorized and directed to begin and prosecute the actions and proceedings, in the manner provided by law, to condemn, take, damage and appropriate the lands and other property necessary to carry out the provisions of this ordinance; and also to take the steps necessary to make such special assessment.

NOW, THEREFORE, by reason of the foregoing facts, an emergency is hereby declared to exist in which it is necessary for the immediate preservation of the public peace, health and safety that this ordinance shall become effective without delaye

Section 5. This ordinance shall take effect and be in force from and after its passage and approval, if approved by the Mayor: otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
