AN ORDINANCE providing for the laving off, extending altering and establishing of the alley in Block Phirteen (13), greene's Addition to the City of Seattle, from the north line, to the north margin of Louisa Street, and Block Thirteen (13), condemnation, appropriation, taking and damaring of land and other property necessary therefor, and providing that the payment upon the property specially benefited, in the manner provided by law.

WHERMAS, Public necessity and convenience demand that the alley in Block Thirteen (13), Greene's Addition to the City of Scattle, be laid off, extended, altered and established, from the north line, produced east, of Lot Nineteen (19), said Block Thirteen (13) to the north margin of Louisa Street, and

WHEREAS, Said improvement will be of special benefit to certain lands, premises and other property, NOW THEREFORE,

BE IT ONDAINED BY THE CITY OF SEATTLE, AS FOLLOWS:

Greene's Addition to the City of Seattle, be and the same is hereby laid off, extended, altered and established, over and across the following described lots, blocks or tracts of land, to-wit: That piece, parcel or tract of unplatted land which lies north of the north line, produced east, of Lot Nineteen (19), Block Thirteen (13), Greene's Addition to the City of Seattle; east of a line which is parallel to and distant twenty (20) feet west from the east margin of the Alley platted in said Block Thirteen (13); west of the west margin of the alley as platted in the northerly portion of said Block Thirteen (13), and south of the north margin, produced west, of Louida Street.

SECTION 2: That all lands rights, privileges and other property lying within the limits of the lots, blocks or tracts of land described in Section One hereof, be and the same are hereby condemned, appropriated, taken and damaged to the public use for the purposes of a public alley.

SECTION 3: That the cost of the improvement provided for herein shall be paid for by special assessment upon the
