ORDINANCE No. 30802

AN ORDINANCE providing for the laying off, extending and establishing of a public street and highway, to be known as Gilman Avenue, from the intersection of Government Way, and Twenty-ninth Avenue West; thence extending northwesterly to the south margin of the Salmon Bay Waterway; of Harley Avenue from a point one hundred forty-one and sixteen one-hundredths (141.16) feet north of the north margin of Lawton Place to the intersection of Thirty-third Avenue West with Commodore Way; providing for the condemnation, appropriation, taking and damaging of land and other property necessary therefor; providing for the changing and establishing of the curb grades of said Gilman Avenue and establishing of the curb grades of said Gilman Avenue and and other property necessary for the grading and regrading of seid avenue and approaches thereto; providing for the such established grades and necessary for the construction of slopes for cuts and fills upon real property abutting upon said avenues and approaches thereto; and providing that the payment for the cost of said improvement be made from the General Fund of the City of Seattle in the manner provided by law.

WHEREAS Public necessity and convenience demand that a public street and highway, to be known as Gilman Avenue, from the intersection of Government Way and Twenty-ninth Avenue West to Salmon Bay Waterway, and Harley Avenue from a point one hundred forty-one and sixteen one-hundredths (141.16) feet, more or less, north of the north margin of Lawton Place to the intersection of Thirty-third Avenue West and Commodore Way, be laid off, extended and established as public streets and highways, now, therefore -

BE IT ORDAINED BY THE CITY OF SEATTLE, AS FOLLOWS:-

Section 1. That a public street and highway to be known as Gilmen Avenue, from the intersection of Government Way and Twenty-ninth Avenue West to the Salmon Bay Waterway; and that Harley Avenue from a point one hundred forty-one and sixteen one-hundredths (141.16) feet, more or less, north from the north margin of Lawton Place to the intersection of Thirty-third Avenue West and Commodore Way, he and the same are hereby laid off, extended and established as public streets and highways over and across the following described lets, blocks and tracts of land, to-wit;-

IN LANTON PARK ADDITION TO THE CITY OF SEATTLE.

That portion of Lot One (1), Block Four (4), described as follows, to-wit;-

Beginning at a point of intersection with the northerly margin of Commodore Way as established by Ordinance No.15923, and the westerly mergin, produced north, of the Alley in Block Eighteen (18), Lawton Park Addition to the City of Seattle; thence westerly along said northerly margin of Commodore Way, a distance of Eighty-five and sixty-four one-hundredths (85.64) feet to a point on the arc of a curve to the right having a uniform radius of one thousand three hundred forty-seven and thirty-four onehundredths (1347.34) feet, said radius bearing north eighty-three degrees, thirty-seven minutes and a seast (N.83-deg., 371, "E) from said point; thence northerly along the arc of said curve a distance of one hundred one and seventy-four onehundredths (101.74) feet to the point of tangency; thence north two degrees, three minutes and twenty-four seconds west (N.2-deg. 03' 24"W) along the tangent of said curve a distance of forty-two (42) feet, more or less, to a point on the southerly line of Lot One (1), Block Nine (9), Seattle Tide Lands; thence easterly along seid southerly line a distance of forty (40) feet, more or less, to a point on the southerly margin of the Salmon Bay Waterway; thence east along said southerly margin a distance of fifty-nine

and twenty-three one-hundredths (59.23) feet; thence south two degrees, three minutes and twenty-four seconds east (S.2-deg., 03' 24" E.) a distance of thirty-seven and eighty-two one-hundredths feet to the point of a curve; thence southerly along the arc of a curve to the left having a uniform radius of one thousand two hundred forty-seven and thirty-four one-hundredths (1247.34) feet, a distance of eighty-seven and sixty-six one-hundredths (87.66) feet to a point on the northeasterly margin of Commodore Way as platted in the Lawton Park Addition to the City of Seattle; thence northwesterly along said northeasterly margin a distance of fifteen and fifty-two one-hundredths (15.52) feet to a point on the westerly margin, produced north, of the Alley in Block Eighteen (18), Lawton Park Addition to the City of Seattle; thence south along said produced west margin a distance of thirty-two and four one-hundredths (32.04) feet to the point of beginning;

Section 2. That all lands, rights, privileges and other property lying within the limits of the lots, blocks or tracts of land described in Section 1 hereof be and the same are hereby condemned, appropriated, taken and damaged to the public use for street and highway purposes forever.

Section 3. That the curb grades of said Gilman Avenue as established herein, from the intersection of Government Way and Twenty-ninth Avenue West to the south margin of the Salmon Bay Waterway, be and the same are established at the following elevations above city datum, to-wit;-

That the curb grades shall be straight lines between the elevations established herein except where said elevations lie in a vertical curve; that the curb grades of the approaches to said Avenue be changed and established to conform to the grades established herein to such distance back from said Avenue, not exceeding the length of one block, as may be necessary;

That the construction of the necessary slopes for cuts and fills upon real property abutting upon said avenue and approaches thereto in accordance with the grades established herein, each cut shall be carried into and extended upon the abutting real property one foot for each foot in depth of cut and each fill shall be carried back and extended upon the abutting real property one and one-half foot for each foot of elevation of fill.

Section 4. That all lands, rights, privileges and other property necessary to be taken, used or damaged in the grading and regrading of said avenue and approaches thereto, in conformity with the grades established in Section 3 hereof; and in the construction of the necessary slopes for cuts and fills upon the property abutting upon said avenue and approaches thereto are hereby condemned to the public use for such purposes.

Section 5. That the cost of the property and property rights necessary to be condemned, appropriated, taken and damaged, in order to carry out the provisions of this Ordinance,

together with the cost of the necessary condemnation proceedings shall be paid from the General Fund.

Section 6. That the Corporation Counsel be and he is hereby authorized and directed to begin and prosecute action and proceedings in the manner provided by law to condemn, take, damage and appropriate the lands and other property necessary to carry out the provisions of this Ordinance.
