ORDINANCE NO. 31176.

AN ORDINANCE, Providing for the laying off, extending and establishing of Smith Street from the westerly line of Tract One (1), Hunter's Lake Union Addition, to Glen Ridge Drive; of Wheeler Street from the westerly line of Tract Two (2), Hunter's Lake Union Addition, to Glen Ridge Drive; of McGraw Street, from the westerly line of Tract Three (3), Hunter's Lake Union Addition, to Taylor Avenue; providing for the condemnation, appropriation, taking and damaging of land and other property necessary therefor; providing that the entire cost of said improvement shall be paid by special assessment upon the property specially benefited in the manner provided by law;

WHEREAS, public necessity and convenience demand that the above named streets be laid off, extended, and established; and

WHEREAS, said improvement will be of special benefit to certain lands, premises, and other property; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE, AS FOLLOWS:

Section 1. That Smith Street, from the westerly line of Tract One (1), Hunter's Lake Union Addition, to Glen Ridge Drive; Wheeler Street, from the westerly line of Tract Two (2), Hunter's Lake Union Addition, to Glen Ridge Drive; and McGraw Street, from the westerly line of Tract Three (3), Hunter's Lake Union Addition, to Taylor Avenue; be laid off, extended, and established, over and across the following lots, blocks or tracts of land, to-wit:

All of Tracts One (1), Two (2), and Three (3), Hunter's Lake Union Addition to the City of Seattle.

Section 2. That all lands, rights, privileges and other property lying within the limits of the lots, blocks or tracts of land described in Section One (1) hereof, be and the same are hereby condemned, appropriated, taken and damaged for street purposes.

Section 3. That the entire cost of the improvement provided for herein shall be paid by special assessment upon

property specially benefitted in the manner provided by law, and that no part thereof shall be paid from the General Fund of the City of Seattle.

Section 4. That the Corporation Counsel be, and he is hereby, authorized and directed to begin and prosecute the action and proceedings, in the manner provided by law, to condemn, take, damage and appropriate the lands and other property necessary to carry out the provisions of this ordinance; and also to take the steps necessary to make such special assessment.

(To be used for all Ordinances except Emergency.)

Section 1. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
