ORDINANCE NO.

AN ORDINANCE providing for the laying off, opening, extending and establishing of a public street and highway to be known as East Marginal Way, from the intersection of Whatcom Avenue and West Spokane Street extending south along Whatcom Avenue and said Thatcom Avenue Produced to Seattle Boulevard; thence continuing southerly and southeasterly to a point on the south line of Section Twenty-eight (23), Township Twenty-four (24) North, Range Four (4) East, W.M., said point being distant one thousand fifty-nine (1059) feet more or less east from the southwest corner of said section; and of Orcas Street from First Avenue South to East Marginal Way as extended herein; providing for the condemnation, appropriation, taking and damaging of land and other property necessary therefor; And providing that the entire cost of said improvement shall be paid by special assessment upon the property specially benefited in the manner provided by law.

WHEREAS, public necessity and convenience demand that the above named way and street be laid off, opened and extended as public streets and highways, and

WHEREAS, such improvement will be of special benefit to certain lands, premises and other property, NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That a public street and highway to be known as East Marginal Way, from the intersection of Whatcom Avenue and West Spokane Street, extending south along Whatcom Avenue and said Whatcom Avenue Produced to Seattle Boulevard; thence southerly and southeasterly to a point on the south line of Section Twenty-eight (28), Township Twenty-four (24) North, Range Your (4) East, W.M., said point being distant one thousand fifty-nine (1059) feet more or less east from the southwest corner of said section; and that Greas Street, from First Avenue South to East Marginal Way as extended herein, be and the same are hereby laid off, opened, extended and established as public streets and highways over and across the following lots, blocks, or tracts of land, to-wit:

That portion of Government Lot One (1), Section Eighteen (18), Township Twenty-four (24) North, Range Four (4) East, W.M., described as follows:

Beginning at the point of intersection of the Fast line of Block Three Hundred Seventy-seven (377), of Seattle Tide
Lands, and the Government Leander Line; thence north a distance of Three Hundred Seventy-five and Two One-hundredths (375.02) feet along the east line produced north of said Block Three Hundred Seventy-seven (377) to a point on the south argin of West Spokane Street; thence east along said south margin a distance of two hundred (200) feet; thence south eight hundred twenty-nine and seventeen one-hundredths (829.17) feet to a point on the Government Meander Line; thence northwesterly along said Meander Line a distance of four hundred ninety-six and sixty-one cos-hundredths (496.61) feet to the point of beginning.

All right, title and interest to any other land, premises or other property lying within the bounds of said East Marginal Way, including all rights in the bed of the Duwamish River within the bounds of said East Marginal Way produced across said River, together with all riparian and littoral rights necessary for a continuous street and highway one hundred thirty (130) feet in width from the intersection of Whatcom Avenue and West Spokane Street extending southerly to a point on the south line of Section Twenty-eight (28), Township Twenty-four (24) North, Range Four (4) East, W. E.

Section 2. That all lards, rights, privileges, and other property lying within the limits of said lots, blocks, and tracts of land described in this ordinance be, and the same are hereby condemned, taken, damaged and appropriated for the public use for the purpose of a public street and highway, forever.

Section 3. That the entire cost of the improvement provided for herein, be paid by special assessment upon the property specially benefited, in the manner provided by law, and that no part thereof be paid from the general fund of the City of Seattle.

Section 4. That the Corporation Counsel be and he is hereby authorized and directed to begin and prosecute the actions and proceedings, in the manner provided by law, to condemn, take, damage and appropriate the lands and other property necessary to carry out the provisions of this ordinance, and to make such special assessment.

Section 5. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the City Charter.
