ORDINANCE NO. 30087

AN ORDINANCE providing for the condemnation, appropriation, taking and damaging of a portion of Lot Thirteen (13), Block Eleven (11), Renton's Addition to the City of Seattle, for street purposes and providing that the entire cost of said improvement shall be paid by special assessment upon property specially benefited in the manner provided by law.

WHEREAS, public necessity and convenience demand that a portion of Lot Thirteen (13), Block Eleven (11), Renton's Addition to the City of Seattle, be condemned, appropriated, taken and damaged for public street and highway purposes, and

WHEREAS, said improvement will be of special benefit to certain lands, premises and other property, NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the following described portion of Lot Thirteen (13), Block Eleven (11), Renton's Addition to the City of Seattle, to-wit:

Beginning at the most southerly corner of said lot Thirteen (13); thence north along the west line thereof a distance of twenty-six and ninety-four one-hundredths (26.94) feet; thence southeasterly along the arc of a cure to the left having a uniform radius of thirty-eight (38) feet that a distance of thirty and eighty-two ne-hundredths (30.82) feet to a point on the southeasterly line of said lot; thence southwesterly along said southeasterly line a distance of thirty-three and fifty-eight one-hundredths (33.58) feet to the point of beginning;

be and the same is hereby condemned, appropriated, taken and damaged, together with all lands, rights, privileges and other property lying within the limits of the above described tract, for street and highway purposes.

vided for nerein shall be paid by special assessment upon the property specially benefited in the manner provided by law, and that no part thereof shall be paid from the General Fund of the City of Seattle.

Section 3. That the Corporation Counsel be, and he is hereby authorized and directed to begin and prosecute the actions and proceedings in the manner provided by law, necessary to carry out the provisions of this ordinance.
