ORDINANCE NO. 39286

AN ORDINANCE providing for the condemnation, appropriation, taking and damaging of land and other property necessary for the extending and establishing of WEST HALLADAY STREET, between Fourth Avenue West and Fifth Avenue West; and providing that the entire cost of said improvement shall be paid by special assessment upon the property specially benefited in the manner provided by law.

WHEREAS, public necessity demands that the land and other property herein specified be condemned, appropriated, taken and damaged for the purpose mentioned herein, and

WHEREAS, such improvement will be of special benefit to certain lands, premises and other property, Now, Therefore,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the following described tract of land, to-wit:

That portion of the south one-half of the northeast quarter of the southwest quarter of the northeast quarter (S. $\frac{1}{4}$ of N.E. $\frac{1}{4}$ of S.W. $\frac{1}{4}$ of N.E. $\frac{1}{4}$) of Section 24, Township 25 North, Range 3 East W.M., lying north of the north line produced west of Block 1, Queen Anne Fourth Addition to the City of Seattle, more particularly described as follows:

Beginning at the northwest corner of said Block 1; thence west along the north line produced west of said Block 1, a distance of Ninety-nine (99) feet to the east margin of Fifth Avenue East as condemned by Ordinance No. 16790; thence north along said east margin a distance of Twenty (20) feet; thence east along a line Twenty (20) feet north from and parallel with the said produced north line of Block 1, a distance of Ninety-nine (99) feet; thence south along a straight line a distance of Twenty (20) feet to the point of beginning.

be and the same is hereby condemned, appropriated, taken and damaged for the extending and establishing of West Halladay Street, between Fourth Avenue West and Fifth Avenue West.

Section 2. That the entire cost of said improvement shall be paid by special assessment upon the property specially benefited in the manner provided by law and that no part thereof shall be paid from the General Fund of the City of Seattle.

Section 3. That the Corporation Counsel be and he is hereby authorized and directed to begin to prosecute an action in the Superior Court of King County in the manner provided

law to condemn, appropriate, take and damage the above described property for the purpose mentioned herein, and also to take the steps necessary to make such special assessment.

(To be used for all Ordinances except Emergency.)

Section 4. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
