ORDINANCE NO.

124....

AN ORDINANCE Providing for the changing and establishing of the curb grades of

9th AVENUE SOUTH, from Massachusetta Street to Diagonal Avenue;

DIAGONAL AVENUE, from 9th Avenue South to Spokane Street; 6th AVENUE SOUTH, from Holgate Street to Lander Street; HOLGATE STREET, from 6th Avenue South to the alley east

of 9th Avenue South; LANDER STREET, from 6th Avenue South to 9th Avenue South; BAY VIEW STREET, from 9th Avenue South to 10th Avenue South;

providing for the condemnation, appropriation, taking and damaging of land, provileges, and other property and property rights agreesary for the grading and regrading of said avenues and streets in conformity with the grades astablished herein, and for cuts and fills upon the property abutting upon said avenues and streets, and specifying the manner of payment of the compensation to be made therefor.

WHEREAS, Public necessity and convenience demand that the curb grades of the above named avenues and strects be changed and established, and that certain lands, privileges, property and property rights necessary for the grading and regrading of said avenues and streets in conformity with such grades as changed and established, be condemned, appropriated, taken or damaged; and

WHEREAS, Such change of grades, condemnation, appropriation, taking and damaging of such lands, privileges, property and property rights for the purposes specified, will be of special benefit to certain lands, premises and other property, now, therefore,

BE IT ORDAINED BY THE CITY OF SEATTLE AS LOLLOWS:

Section 1. That the curb grades of:

9th AVENUE SOUTH, from Massachusetts Street to Diagonal Avenue;

DIAGONAL AVENUE, from 9th Avenue South to Spokene Street;

6th AVENUE SOUTH, from Holgete Street to Lander Street;

HOLGATE STREET, from 6th Avenue South to the alley east of 9th Avenue South;

LANDER STREET, from 6th Avenue South to 9th Avenue South;

BAY VIEW STREET, from 9th Avenue South to 10th Avenue South;

be and the same are hereby changed and established to conform with the grades established by Oriinance No.43146, insofar as the same may apply, at the following elevations above city datum, to-wit:

That the curb gradients shall be of a uniform rate of grade between the elevations established herein.

That for the purposes of grading and Section 2. regrading said avenues and streets in conformity with the grades established in Section 1 hereof, and constructing the necessary slopes for cuts and fills upon lands abutting upon said avenues and atreets, all necessary lands, privileges and other property and property rights are hereby condemned, appropriated, taken, or damaged; that in the case of cuts the right is hereby appropriated to remove the lateral support to lands abutting upon said avenues and streets and to carry the slope back into and extending upon such lands at least one foot for each foot of depth of cut; that in the case of fills the right is hereby appropriated to extend and maintain upon abutting and adjoining lands slopes extending one and onehalf feet horizontally for each foot of elevation of fill, to afford lateral support for said avenues and streets, reserving unto the abutting property owners respectively the right at any time to remove such slopes, upon providing other adequate lateral support.

Section 3. That the purposes specified in Section 2 hereof are hereby declared to be a public object and a public use; and said lands, privileges, property and

property rights shall be condemned, appropriated, taken or damaged only after just compensation shall have first been made or paid into court for the owners or persons entitled thereto in the manner provided by law.

Section 4. That the Corporation Counsel be, and he is hereby, authorized and directed to begin and prosecute in the manner provided by law the necessary actions or proceedings to condemn, appropriate, take or demage the lands, privileges, property and property rights necessary to carry out the provisions of this Ordinance.

Section 5. That the compensation to be made for lands, privileges, property and property rights condemned, appropriated, taken or demaged as herein provided, together with the accruing costs of the necessary actions or proceedings shall be added to the cost of the labor and material necessary for the grading and regrading of said avenues and streets, as provided for by Ordinance No. 44472, creating Local Improvement District No. 3444, and shall be paid by assessment upon the property specially benefited by such improvement, in the manner provided by law, or from such other funds as the City Council of The City of Seattle may direct.

Section .6. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor, otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
