AN ORDINANCE providing for the laying off, opening, widening, extending and establishing of WEST 85th STREET and NORTH 85th STREET, between 24th Avenue Northwest and Meridian Avenue, all in The City of Seattle; providing for the condemnation, appropriation, taking and damaging of lands and other property necessary therefor, and providing that the entire cost of said improvement be paid by special assessment upon property specially benefited, in the manner provided by law.

WHEREAS, Public necessity and convenience demand that WEST 85th STREET and NORTH 85th STREET, between 24th Avenue Northwest and Meridian Avenue, all in The City of Seattle, be laid off, opened, widened, extended and established, and

WHEREAS, Such improvement will be of special benefit to certain lands, premises and other property, NOW,
THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That WEST 85th STREET and NORTH 85th STREET, between 24th Avenue Northwest and Meridian Avenue, all in The City of Seattle, be and the same is hereby laid off, opened, widened, extended and established over and across the following lots, blocks or tracts of land, to-wit:

The north thirty (30) feet of the northwest one-quarter ($\frac{1}{4}$) of the northeast one-quarter ($\frac{1}{4}$), of Section 2, Township 25 North, Range 3 East, W.M.

The north fifteen (15) feet of Tract Fifteen (15), Scheuermann's Garden Acre Tracts to The City of Ballard, now a portion of The City of Seattle.

The north fifteen (15) feet of Tracts Five (5) and Six (6), Scheuermann's Garden Acre Tracts No. 2, to the City of Ballard, now a portion of The City of Seattle.

The north thirty (30) feet of the northeast one-quarter ($\frac{1}{4}$) of the northwest one-quarter ($\frac{1}{4}$) of the northeast one-quarter ($\frac{1}{4}$) of Section 6, Township 25 North, Range 4 East, W.M., except the east thirty-five (35) feet thereof.

The north thirty (30) feet of the northeast one-quarter ($\frac{1}{4}$) of the northwest one-quarter ($\frac{1}{4}$) of the northeast one-quarter ($\frac{1}{4}$) of the northeast one-quarter ($\frac{1}{4}$) of Section 6, Township 25 North, Range 4 East, W.M., except the east thirty (30) feet thereof.

The north thirty (30) feet of the northeast one-quarter ($\frac{1}{4}$) of the northeast one-quarter ($\frac{1}{4}$) of the northeast one-quarter ($\frac{1}{4}$) of Section 6, Township 25 North, Range 4 East, W.M.

Section 2. That all lands, rights, privileges and other property lying within the limits of the lots, blocks and tracts of land described in Section One (1) hereof, be and the same are hereby condemned, appropriated, taken and damages as a public street and highway - forever.

Section 3. That the entire cost of the improvement provided for herein shall be paid by special assessment upon the property specially benefited, in the manner provided by law, and that no part thereof shall be paid from the General Fund of The City of Seattle.

Section 4. That the Corporation Counsel be, and he is hereby authorized and directed to begin and prosecute the actions and proceedings, in the manner provided by law, to condemn, take, damage and appropriate the lands and other property necessary to carry out the provisions of this ordinance and also to take the steps necessary to make such special assessment.

(To be used for all Ordinances except Emergency.)

Section 5. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
