## ORDINANCE NO. 53676

AN ORDINANCE providing for the laying off, opening, widening, extending and establishing of 24th AVENUE HORTHWEST, between West 73d Street and West 75th Street, and WEST 75th STREET, between 24th Avenue Horthwest and 25th Avenue Northwest; providing for the condemnation, appropriation, taking and damaging of land and other property necessary therefor; and providing that the entire cost of said improvement shall be paid by special assessment upon property specially benefited, in the manner provided by law.

WHEREAS, public necessity and convenience demand that 24th
Avenue Northwest, between West 73d Street and West 75th Street,
and West 75th Street, between 24th Avenue Northwest and 25th Avenue Northwest, be laid off, opened, widened, extended and established; and

WHEREAS, such improvement will be of special benefit to certain lands, premises and other property, NOW THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That 24th Avenue Northwest between West 73d Street and West 75th Street, and West 75th Street between 24th Avenue Northwest and 25th Avenue Northwest, be and the same is hereby laid off, opened, widened, extended and established over and across the following lots, blocks or tracts of land, to-wit:

twenty-five (25) North Range three (3) East W.C., not
previously platted, which lies east of a line seventyfive (75) feet west from and parallel with west lines
of blocks are hundred forty-ove (141) and one hundred of blocks one hundred forty-one (141) and one hundred forty-four(144) Salmon Bay Park Addition to the City of Seattle, as recorded in Volume four (4) of Flats Page seventy-six(76); except portion dedicated for street purposes by Ordinance No. 20654;

one-quarter (1) of Section two (2) Township twenty-five (25) North Range three (3) East W.M. not previously platted, which lies northerly of a line fifty-five (55) feet southerly from and parallel with the "outherly line of Block seventeen (17). H.E.Nelson Addition to the City of Seattle, Volume twenty-eight (28) of Plats, Pages twenty-one (21) and twenty-two(22); except portion thereof included in the above description.

Section 2. That all lands, right, privileges and other property lying within the limits of the lots, blocked and tracts of land described in Section 1 hereof be and the same are hereby condemned, appropriated, taken and damaged as public streets and highways.

Section 3. That the entire cost of the improvement provided for herein shall be paid by special assessment upon the property specially benefited, in the manner provided by law, and that no part thereof shall be paid from the General Fund of the City of Seattle.

Section 4. That the Corporation Counsel be, and he is hereby authorized and directed to begin and prosecute the actions and proceedings, in the manner provided by law, to condemn, take, damage and appropriate the lands and other property necessary to carry out the provisions of this ordinance and also to take the steps necessary to make such special assessment.
