ORDINANCE NO. 54108

AN ORDINANCE Providing for the condemnation, appropriation and taking of certain tracts of land and other property in the Plat of Alki Point, now a portion of the City of Seattle, and the tide lands adjoining, for park and parkway purposes, and providing that payment therefor shall be made in whole or in part by special assessment upon property specially benefited in the manner provided by law, or from the General Fund of the City of Seattle, or from such other fund as the City Council may provide.

WHEREAS, Public necessity and convenience demand that certain property and the tide lands adjoining, in the Plat of Alki Point, be used for park and parkway purposes; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the following described real estate situated in the City of Seattle, King County, Washington, be condemned, appropriated, and taken by the City of Seattle for park and parkway purposes, to-wit:

All of Tracts Q, R, S, and T, in the Plat of Alki Point, now a portion of the City of Seattle, and all of the tide lands adjoining;

All of Tract U, in the Plat of Alki Point, now a portion of the City of Seattle.

Section 2. That all lands, rights, privileges, and other property lying within the limits of the tracts of land described in this ordinance be, and the same are hereby condemned, appropriated and taken for the public use for park and parkway purposes.

Section 3. That the improvement provided for herein shall be paid for in whole or in part by special assessment upon the property specially benefited in the manner provided by law, or from the General Fund of the City of Seattle, or from such other fund as the City Council may provide.

Section 4. That the Corporation Counsel be and he is hereby authorized and directed to begin and prosecute

the actions and proceedings, in the manner provided by law, to condemn, take and appropriate the lands and other property necessary to carry out the provisions of this ordinance.

(To be used for all Ordinances except Emergency.)

Section 5. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
