ORDINANCE NO.

AN ORDINANCE Providing for the laying off, opening, widening extending and establishing of a public street and highway to be known as Empire Way from the intersection of 42nd Avenue South and Empire Way, as established by Ordinance No. 30673, southerly to the City Limits, and of a public street and highway to be known as Dunlap Way from Empire Way, as extended herein, at a point approximately 1200 feet north from the intersection of said Empire Way with the south City limits southwesterly to an intersection with the south City limits at a point approximately 1115 feet westerly from the center of Section 3, Township 23 North, Range 4 East, W.M., and of Holden Street, from Empire Way as established herein, to Renton Avenue; Providing for the changing and establishing of the curb grades of said ways and street; Providing for the condemnation, appropriation, taking and damaging of land and other property necessary therefor and for the making of the necessary slopes for cuts and fills upon the property abutting upon said ways and street; Providing for the condemnation, appropriation and taking of land in fee simple for general municipal purposes; Providing for the changing of the names of certain streets and avenues; Providing that the cost of the improvement shall be paid by special assessment upon the property specially benefited in the manner provided by law, except as herein otherwise provided.

WHEREAS, publi necessity and convenience demand that the above named ways a i street be laid off, opened, widened, extended am established as public streets and highways and that the curb grades of the same be changed and established and that certain property be taken for general municipal purposes; and

MEREAS, such improvement will be of special benefit to certain lands, premises and other property, NOW, THEREFORE,

## BE IT CRDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That a public street and highway to be known as Empire Way, from the intersection of 42nd Avenue South and Empire Way, as established by Ordinance No. 30673, southerly to the City Limits, and of a public street and highway to be known as Dunlap Way from Empire Way, as extended herein, at a point approximately 1200 feet north from the intersection of said Empire Way with the south City Limits southwesterly to an intersection with the south City Limits

at a point approximately 1115 feet westerly from the center of Section 3, Township 23 North, Range 4 East, W.M., and of Holden Street, from Empire Way as established herein, to Renton Avenue, be and the same are hereby laid off, opened, widened, extended and established as public streets and highways over and across the following lots, blocks and tracts of land, to-wit:

That in the grading and regrading of the above named ways and street the Sity shall acquire the right in the case of a cut to remove the lateral support of the property abutting on said ways and street. In every case the right to remove said lateral support shall include the right to carry the

slopes back into and extending upon the abutting real property at least one (1) foot for each foot of depth cut, and in the case of fills, the right shall be acquired to extend and maintain upon the abutting real property slopes of one and one-half (1½) feet for each foot of elevation of fill for the purpose of acquiring lateral support for said ways and street, reserving unto the abutting property owners respectively the right at any time to remove such slopes upon providing other adequate lateral support for said ways and street.

That all lands, rights, privileges and Section 5. other property lying within the limits of the lots, blocks and tracts of land described in Section 1 hereof be and the same are hereby condemned, appropriated, taken and damaged for the purpose of public streets and highways and that all lands, rights, privileges and other property necessary to be taken, used or damaged in the grading and re-grading of said ways and street in conformity with the grades established in Section 3 hereof and in the construction of the necessary slopes for cuts and fills upon the real property abutting on said ways and street, as set forth in Section 4 hereof, are hereby condemned, appropriated, taken and damaged for the public use for such purposes; and said lands, rights, privileges and other property are to be taken, damaged and appropriated only after just compensation has been made or paid into Court for the occas thereof in the manner provided by law.

Section 6. That the entire cost of the improvement provided for herein shall be paid by special assessment upon the property specially benefited in the manner provided by law, except that portion of the improvement provided for in Section 2 hereof shall be paid from the General Fund of the City of Seattle.

Section 7. That the Corporation Counsel be and he is hereby authorized and directed to begin and prosecute the actions and proceedings in the manner provided by law to condemn, take and appropriate the lands and other property necessary to carry out the provisions of this ordinance and to take the steps necessary to make such special assessment.

Section 8. That the name of 42nd Avenue South, from Empire Way as established by Ordinance No. 30673 to a point approximately five hundred (500) feet north of Thistle Street, be changed to Empire Way.

That the name of 43rd Avenue South from Henderson Street to Beacon Avenue be changed to Empire Way.

Section 9.. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
