ORDINANCE No. 50281

AN ORDINANCE Providing for the laying off, opening, extending and establishing of a public alley over and across Block 29, Mercer's 2nd Addition to North Seattle, now a portion of the City of Seattle, from 3rd Avenue North to Nob Hill Avenue; providing for the condemnation, appropriation, taking and damaging of land and other property necessary therefor, and providing that the entire cost of said improvement shall be paid by special assessment upon property specially benefited, in the manner provided by law.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That a public alley over and across Block 29, Mercer's 2nd Addition to North Seattle, now a portion of the City of Seattle (Volume 2 of Plats, page 7), from 3rd Avenue North to Nob Hill Avenue, be and the same is hereby laid off, opened, extended and established over and across the following lots, blocks or tracts of land, to-wit:

The north four (4) feet of Lot two (2), Block twentynine (29);
The south eight (8) feet of Lot three (3), Block twentynine (29);
The south eight (8) feet of Lot Six (6) and of vacated
street adjoining said Lot Six (6), Block twenty-nine (29); and
The north four (4) feet of Lot seven (7) and of vacated
street adjoining said Lot seven (7), Block twenty-nine (29).

Section 2. That all lands, rights, privileges and other property lying within the limits of the lots, blocks and tracts of land described in Section One (1) hereof, be and the same are hereby condemned, appropriated, taken and damaged as a public alley.

Section 3. That the entire cost of the improvement provided for herein shall be paid by special assessment upon the property specially benefited, in the manner provided by law, and that no part thereof shall be paid from the General Fund of the City of Seattle.

Section 4. That the Corporation Counsel be, and he is hereby authorized and directed to begin and prosecute the action and proceedings, in the manner provided by law, to con-

demm, take damage and appropriate the lands and other property necessary to carry out the provisions of this ordinance and also to take the steps necessary to make such special assessment.
