ORDINANCE NO. 64367

AN ORDINANCE relating to the Municipal Street Railway Division of the Board of Public Works and to the transportation of the blind thereon, and appropriating money to defray the cost and expense thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the transportation of the indigent blind on the cars of the Municipal Street Railway Division of the Board of Public Works be and it is hereby authorized during the year 1934, and the Superintendent of Railways is authorized and directed to prepare suitable forms for identifying applicants for this privilege and to issue such identification cards or passes as may be necessary to permit of their use on the railway cars during the year 1934.

Section 2. In order to defray the cost and expense of transporting the blind on the cars of the Municipal Street Railway during the year 1934, the sum of three hundred dollars (\$300.00) is appropriated from the General Fund to the City Railway Fund, and the City Comptroller is authorized and directed to draw the necessary warrant for such purpose.



Section \_\_\_\_ This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
