ORDINANCE No. 65623

AN ORDINANCE Relating to and providing for the construction of a reinforced concrete and structural steel overhead pedestrian crossing over Montlake Boulevard, and appropriating money therefor.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

H 17  
Section 1. That the Board of Public Works be and it is hereby authorized and directed to construct a reinforced concrete and structural steel overhead pedestrian crossing over Montlake Boulevard, just north of the University of Washington Athletic Pavilion, and to do such other work as may be necessary in connection therewith, all in accordance with plans to be prepared by the City Engineer and approved by the Board of Public Works.

Section 2. That the sum of Thirty Thousand Dollars (\$30,000.00), or so much thereof as may be necessary, be and the same is hereby appropriated from the Gas Tax Highway Fund for the purpose set forth in Section 1 hereof.

(To be used for all Ordinances except Emergency.)

Section 3. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
