AN ORDINANCE Changing the name of Railroad Avenue to Alaskan Way;
the name of Railroad Avenue South to South Alaskan Way and
the name of Railroad Avenue West to North Alaskan Way.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the name of the street now known as Railroad Avenue from Yesler Way to Denny Way be, and the same is hereby, changed to Alaskan Way.

That the name of the street now known as Railroad Avenue South from Yesler Way to Holgate Street be, and the same is hereby, changed to South Alaskan Way; and

That the name of the street now known as Railroad Avenue West from Denny Way to West Garfield Street be, and the same is hereby, changed to North Alaskan Way.

(To be used for all Ordinances except Emergency.)

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
