## ORDINANCE NO. 66630

AN ORDINANCE accepting a deed from the Olson Land Company, a corporation, to the City of Seattle, and laying off Point Place, West Hanford Street, Benton Place, and

RE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the deed from the Olson Land Company, a corporation, to the City of Seattle, executed August 20th, 1936, to the following described parcels or tracts of land, situated in Tracts M, 16, 17, 18 and 22 of the Plat of Alki Point as recorded on page 19 of Volume 18, of Plats of King County, Washington:

- Parcel "A". That Benton Place be and the same is hereby laid off, opened, extended and established over and across the lands described in Section 1 hereof and designated as Parcel "F".

That Public Alley be and the same is hereby laid off, opened, extended and established over and across the lands described in Section 1 hereof and designated as Parcel "G". (To be used for all Ordinances except Emergency.)
