ORDINANCE NO. 67513

AN ORDINANCE relating to the preparation of plans for the construction of the Cowen Park Bridge and for the improvement of 4th Avenue South, and appropriating additional money therefor.

WHEREAS, heretofore by Ordinance No. 65798, as amended by Ordinance No. 66340, the City Council has appropriated the sum of \$5,200.00 for the preparation of plans for the construction of the Cowen Park Bridge and for the improvement of 4th Avenue South; and

WHEREAS, the amount appropriated is insufficient to pay the cost of the same and an additional appropriation of \$150.00 is necessary therefor; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the sum of One Hundred Fifty Dollars (\$150.00), or so much thereof as may be necessary, be and the same is hereby appropriated from the City Street Fund for the purpose of completing the preparation of plans for the construction of the Cowen Park Bridge and for the improvement of 4th Avenue South, heretofore authorized by Ordinance No. 65798, as amended by Ordinance No. 66340.

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
