## ORDINATICE NO. 73081

AN ORDINANCE relating to the municipal water supply system and providing for the acquisition by condemnation of certain lend, property and property rights in Jefferson Park No. 2 Addition for additions and betterments to the Beacon Hill Weter Reservoir site, and providing that the cost thereof shall be paid from the Water Fund.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That public necessity and convenience demend that the following described property:
