ORDINANCE NO. 73187

AN ORDINANCE providing for the repair and resurfacing of the roadway portion of Hubbell Place, from Pike Street to Union Street, and appropriating money therefor.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the Board of Public Works be and it is hereby authorized and directed to repair and resurface the roadway portion of Hubbell Place, from Pike Street to Union Street, and to do such other work as may be necessary in connection therewith, all according to plans prepared by the City Engineer and approved by the Board of Public Works. Said improvement shall be effected by the awarding of a contract or contracts therefor, or, in the discretion of said Board, the same or any part thereof may be done by day labor.

Section 2. That the sum of Eight Thousand Dollars (\$8,000.00), or so much thereof as may be necessary, be and the same is hereby appropriated from the City Street Fund for the purpose set forth in Section 1 hereof.

Section ³..... This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
