ORDINANCE NO. 75391

AN ORDINANCE relating to and providing for the condemnation of Lots 6, 7, 8, 14, 15 and 16 of Block 11, Cove Addition for Park and Playground purposes and providing that the entire cost of such improvement shall be paid by special assessments on the property specially benefited, or from such fund as the City Council of the City of Seattle may direct, or by both special assessment and such fund.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That public necessity and convenience demand that the following described property, to-wit: Lots 6, 7, 8, 14, 15 and 16, all of Block 11, Cove Addition to the City of Seattle as recorded in Volume 1 of King County Plats at page 73, together with all rights, privileges and other property pertaining thereto, be and the same are hereby condemned, appropriated and taken for a public use, namely, for Park and Playground purposes, as a part of the Park and Playground System of the City of Seattle. Said lands, rights, privileges and other property to be condemned, appropriated and taken only after just compensation has been made or paid into Court for the owners thereof, in the manner provided by law.

Section 2. That the entire cost of the improvement provided for herein shall be paid by special assessments upon property specially benefited, or from such fund as the City Council of the City of Seattle may direct, or by both special assessment and such fund.

Section 3. That the Corporation Counsel be and he is hereby authorized and directed to begin and prosecute the actions and proceedings, in the manner provided by law, to condemn, take and appropriate the lands and other property necessary to carry out the provisions of this ordinance.

(To be used for all Ordinances except Emergency.)

Section 4. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
