ORDINANCE NO. 76271

AN ORDINANCE providing for the laying off, opening, widening, extending and establishing of WEST MARGINAL WAY, from its intersection with Seventh Avenue South to Twelfth Avenue South; providing for the acquisition, appropriation, taking, and damaging of land and other property necessary therefor; and for the making of the necessary slepes for cuts and fills upon the property abutting on said WEST MARGINAL WAY; providing for the taking of land for general municipal purposes by purchase and/or condemnation; and providing for the payment therefor.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That public necessity and convenience demand that WEST MARGINAL WAY from its intersection with 7th Avenue South to its intersection with 12th Avenue South be laid off, opened, widened, extended and established as a public street and highway.

Section 2. That WEST MARGINAL WAY between 7th Avenue South and 12th Avenue South be and the same is hereby laid off, opened, widened, extended, and established over and across the following lots, blocks and tracts of land, to wit:

said WEST MARGINAL WAY, the City shall acquire the right to make all necessary slopes for cuts and fills upon the property abutting upon said street. In case of cut the right shall be acquired to remove the lateral support, including the right to carry the slopes back into and extending upon the abutting real property at least one (1) foot for each foot of depth of cut; and in the case of fills, the right shall be acquired to extend and maintain upon the abutting real property slopes of one and one-half (1) feet for each foot of elevation of fill for the purpose of acquiring lateral support for said street, reserving unto the abutting property owners, respectively, the right at any time to remove such slopes upon providing and maintaining other adequate lateral support for said streets.

Section 4. That all lands, rights, privileges and other property lying within the limits of the lots, blocks, and tracts of land described in Section 2 hereof, be and the same are hereby con-

demned, appropriated, taken and damaged for the purpose of public streets and highways; and that all lands, rights, privileges and other property necessary to be taken, used, or damaged in the construction of the necessary slopes for cuts and fills upon the real property abutting upon said WEST MARGINAL WAY, as set forth in Section 3 hereof, are hereby condemned, appropriated, taken, and damaged for the public use for such purposes; and said 1 ds, rights, privileges and other property are to be taken, damaged and appropriated only after just compensation has been made or paid into court for the owners thereof, in the manner provided by law.

Section 5. That the following lots, blocks, tracts or parcels of land and appurtenances thereunto and belonging, be and the same are hereby to be acquired, appropriated and taken by purchase and/or condemnation in fee simple for general municipal purposes, to wit:

Those portions of Lots 19, and 20, Block 27, lying southwesterly of WEST MARGINAL WAY as laid off, opened, widened, extended, and established under Section 2 of this ordinance.



Section 6. That the entire cost of the improvement provided for herein shall be paid from the City Street Fund, except that the land taken for general municipal purposes shall be paid for from the General Fund of the City of Seattle.

Gentlemen:

We are submitting herewith in accordance with an agreement with the Streets and Sewers Committee, council bill providing for the extension of West Marginal Way, from 7th Avenue South to 12th Avenue South, said property to be acquired by negotiation and/or condemnation.

It is proposed to pay the cost of acquiring the street area from City Street funds, but the cost of acquiring portions of several lots for general municipal purposes m be paid from the General Fund.

In accordance with the usual custom in such cases, we have not appropriated any funds as a part of this ordinance. A separate bill will be introduced providing for funds as soon as this bill has been approved.
