ORDINANCE NO. 76937

AN ORDINANCE vacating portion of Spokane Street, on petition of J. A. Campbell Company, et al.

WHEREAS there has been filed with the City Council the petition of J. A. Campbell Company, et al., (City Comptroller's File No. 195831), for the vacation of portion of Spokane Street, as therein fully described; and

WHEREAS at the hearing on said petition on the 5th day of April, 1948, said petition was duly granted by the City Council; Now, Therefore,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That

A portion of Spokane Street as platted abutting Block 234, Seattle Tide Lands, and Block 25, South Seattle Addition, described as follows:

Beginning at the northwest corner of Block 234, Seattle Tide Lands; thence on the west line of said block extended north 0.28 feet; thence on a straight course east 256.00 feet to a point on the east line of Block 25 extended north, which said point is 2.31 feet north of the northeast corner of said Block 25; thence on said extended east line, south 2.31 feet to the northeast corner of said Block 25; thence on the north line of Blocks 25 and 234, west 256.00 feet to the place of beginning,

be and the same is hereby vacated.

(To be used for all Ordinances except Emergency.)

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
