ORDINANCE NO. 85187

AN ORDINANCE relating to the improvement of Prater Avenue Southwest from 57th Avenue Southwest to West Spokane Street, and certain other streets and avenues, by grading and otherwise improving the same, at the sole cost and expense of Carl W. Anderson and amending Section 1 of Ordinance No. 85187, by adding a street thereto.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That Section 1 of Ordinance No. 85187 entitled:

"AN ORDINANCE granting permission to Carl W. Anderson to improve Prater Avenue Southwest, from 57th Avenue Southwest to West Spokane Street, and certain other streets and avenues, by grading and otherwise improving the same, at his own cost and expense,"

approved May 29, 1956, be and the same is hereby amended to read as follows:

Section 1. That Carl W. Anderson be, and he is hereby granted permission to improve:  
PRATER AVENUE SOUTHWEST from 57th Avenue Southwest to West Spokane Street;  
by grading and graveling the same; constructing sewers together with the necessary appurtenances; constructing watermains together with fire hydrants and the necessary appurtenances; providing for the necessary surface drainage; also  
WEST SPOKANE STREET from 56th Avenue Southwest to the west line of Anderson's Soundview Terrace Addition No. 2,  
by grading and graveling the same; providing for the necessary surface drainage; and otherwise improving the same; all at his own cost and expense.

(To be used for all Ordinances except Emergency.)

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.


Gentlemen:

We transmit herewith for your approval a council bill amending private contract Ordinance No. 85187, relating to the grading of Frater Avenue Southwest from 57th Avenue Southwest to West Spokane Street, and certain other streets and avenues, at the expense of Carl W. Anderson by adding a portion of West Spokane Street to the project.

Since initiating this project at Mr. Anderson's request, it has become obvious that a short section of West Spokane Street adjoining his development should be included in order that this project tie in with other planned grading on West Spokane Street.

We respectfully recommend that Ordinance No. 85187 be amended to include that portion of West Spokane Street between Frater Avenue Southwest and the west line of Anderson's Soundview Terrace Addition No. 2.
