ORDINANCE 86463

AN ORDINANCE finding that "blighted areas" as defined by the Urban Renewal Law exist in the City of Seattle and that rehabilitation, redevelopment or a combination thereof is necessary.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the legislative authority of the city hereby finds that "blighted areas" as defined by the Urban Renewal Law, Chapter 42, Session Laws of 1957, exist in the City of Seattle and that rehabilitation, redevelopment, or a combination thereof of such areas is necessary in the interest of the public health, safety, morals or welfare of residents thereof.

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
