AN ORDINANCE providing for the acquisition by condemnation of certain property in Blocks 19, 20, lll and 45 of Lakewood Addition, a replat of part of Maynard's Lake Washington Addition, in Blocks 18 and 35 of Maynard's Lake Washington Addition, to the City of Seattle, and in Blocks 29 and 30 of Squire's Lakeside Addition, for extension of the present Wetmore Slough Sanitary Fill Site.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FULLOWS:

Section 1. That public necessity requires the following described property situated in King County, Washington, to-wit:

IN LAKEWOOD ADDITION, A REPLAT OF PART OF MAYNARD'S LAKE WASHINGTON ADDITION, (recorded in Volume 10 of King County Plats, at Page 46.)

Lots 1 through 4, inclusive, and Lots 13 through 15, inclusive; Block 19; also, Lots 1 through 12, inclusive, Block 20; also, Lots 11 and 12, and Lots 16 through 24, inclusive; Block 44; also, Lots 1 through 6, inclusive, Lots 13 and 14, Lots 17 and 18, and Lots 23 and 24, all in Block 45.

IN MAYNARD'S LAKE WASHINGTON ADDITION TO THE CITY OF SEATTLE, (recorded in Volume 2 of King County Plats, at Page 33.)

Lot 5, and Lots 8 through 11, inclusive, Block 18; also, Lots 5 and 6, and the west one-half of Lots 7 and 8, Block 35.

Section 2. That the Corporation Counsel is hereby authorized and directed to begin and prosecute the actions and proceedings in the manner provided by law, necessary to carry out the provisions of this ordinance.
