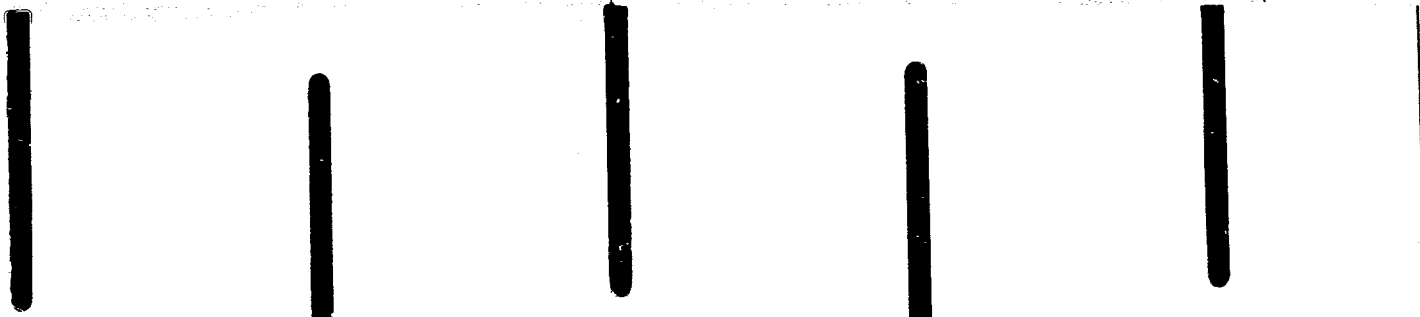

ORDINANCE 86073

AN ORDINANCE transferring jurisdiction over certain unimproved property acquired in connection with the widening of East 58th Street to the Park Department for better access to Ravenna Park.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That jurisdiction over the following unimproved property in Seattle, King County, Washington, to-wit:

Portion of East 58th Street described as follows:

Beginning at the intersection of the northerly line of East 58th Street, as established by Ordinance No. 78390 with the northwesterly line of that portion of East 58th Street established by Ordinance No. 76711; thence easterly along the arc of a curve to the right having a radius of 50 feet and whose radial center bears south 20°34'25" east a distance of 31.02 feet to a point of tangency, said point being 34.50 feet northerly of (measured at right angles) the south line of East 58th Street; thence south 75°01'22" east parallel with said south line to its intersection with the southerly line of Ravenna Park, as established by Ordinance No. 79098; thence northwesterly along said southerly line to its intersection with the northwesterly line of that portion of East 58th Street established by Ordinance No. 76711; thence southwesterly along a straight line to the beginning.

acquired from King County in connection with the widening of East 58th Street is hereby transferred to the Park Department to provide better access to Ravenna Park, all as contemplated by the City Engineer in

C. F. 239265.

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
