WHEREAS, between December 2009 and February 2013, a number of Council Bills, Resolutions, and Clerk Files were introduced but were never acted upon by the City Council; and



BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEATTLE, THAT:


The Council Bills, Resolutions, and Clerk Files, listed on Attachment A, are retired and removed from consideration by the City Council or the assigned committee.

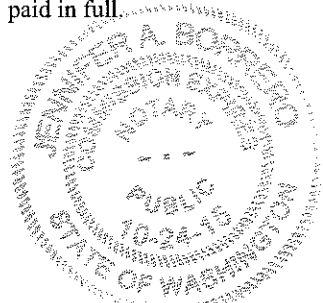
