A RESOLUTION and Proposition to amend Article XXIII of the City Charter of the City of Seattle, and providing for the submission of such proposed amendment to the qualified voters of the City of Seattle at the next general election.
Be it resolved by the City Council of the City of Seattle:
That Article XXIII of the City Charter of the City of Seattle be amended by adding thereto a section to be known as "Section 2," to read as follows:
"Section 2. Every contractor and subcontractor performing any local improvement work for the City of Seattle shall pay or cause to be paid to his employees on such work not less than the current rate of wages paid by the City of Seattle for work of like character and in any event not less than two and seventy-five hundredths (\$2.75) dollars per day. Such contractor and subcontractor shall, on such work, give preference to resident laborers. This article shall be enforced by the City Council by ordinance.
And he it is further resolved that said proposed amendment be submitted to the electors of the City of Seattle for ratification or rejection at the general election to be held in the City of Seattle, March 6, 1912.
