

#### RESOLUTION NO. 6217

Whereas, the people of Ireland, having for centuries suffered the long catalogue of wrongs and oppressions set out in the American Declaration of Independence, having, like the American Colonists, petitioned in vain for the redress of these wrongs, and having, like these Colonists, finally and reluctantly come to the conclusion that nothing but final separation from England could secure to them the natural rights of man, and therefore proclaimed Ireland to be a free and independent Republic and organized a government with Famonn De Valera, a native of the United States, as the President of the Irish Republic; and

Whereas, President De Valera is now in the United States and about to visit the Pacific Coast;

Now Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEATTLE:

That Eamonn De Valera be requested to wisit the City of Seattle and address its people upon the condition of affairs in Ireland. And be it

FURTHER RESOLVED that the Mayor be requested to communicate to President De Valera this invitation from the City of Seattle, and to make arrangements for the proper reception of the distinguished visitor.


