Motion was made by Councilmember Lewis, duly seconded and carried, to amend Council Bill 120366, Section 15, and renumber the remaining sections accordingly, as shown in the strike through and underlined language below:

Section 15. The proviso in Council Budget Action LAW-001-A-002 is amended as follows: "Of the appropriations in the 2022 budget for the City Attorney's Office Criminal Budget Summary Level (BO-LW-J1500), ~~\$1,110,859~~ \$910,231 is appropriated solely for pre-filing diversion and may be spent for no other purpose."

Section ~~45~~16. Any act consistent with the authority of this ordinance taken after its passage and prior to its effective date is ratified and confirmed.

Section ~~46~~17. This ordinance shall take effect and be in force 30 days after its approval by the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.


