**1. BILL SUMMARY**

**Legislation Title:** A RESOLUTION endorsing Washington Animal Trafficking, Initiative 1401, on the ballot in Washington on November 3, 2015.

**Summary and background of the Legislation:** This legislation states the City Council and Mayor’s support of Initiative 1401 (I-1401). I-1401 would strengthen Washington’s laws against trafficking in products derived from ten iconic and threatened animal species (elephants, rhinos, lions, tigers, cheetahs, leopards, pangolins, marine turtles, sharks and rays), five of which are represented and protected at the Woodland Park Zoo and Seattle Aquarium.

This legislation urges Seattle voters to support I-1401 in the November 3, 2015 general election.
