ORDINANCE 103077

AN ORDINANCE relating to the General Donations and Gift Trust Fund; establishing a "PONCHO Display Case" account therein, authorizing acceptance of a donation from PONCHO and other donations thereto and appropriating the same to provide a display case for the exhibition of artifacts from the Museum of History and Industry.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the donation by PONCHO (Patrons of Northwest Civic, Cultural and Charitable Organization) in the amount of Nine Hundred Dollars (\$900) to The City of Seattle for the purpose of constructing a display case to be located in the lobby outside the City Council Chambers to house a rotating exhibit of artifacts from the Museum of History and Industry is hereby accepted, provided that an appropriate designation will be placed on said display case indicating that it was obtained as a result of a PONCHO gift, said donation to be deposited in the General Donations and Gift Trust Fund and credited to a "PONCHO Display Case" account hereby established in said Fund, and the City Treasurer is authorized and directed to accept on behalf of The City of Seattle moneys donated and contributed for said purpose and to give his receipt and the City Comptroller to keep appropriate accounts therefor.

Said donation and all such donations and contributions deposited in said fund and credited to said account are hereby appropriated for the purpose of constructing said display case and the City Comptroller is authorized to draw and the City Treasurer to pay warrants against such account on vouchers approved by the Superintendent of Buildings, all as requested in C.F. 277700.

Section 2. Any act pursuant to the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.

(To be used for all Ordinances except Emergency.)

Section...3... This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.


