ORDINANCE 103334

AN ORDINANCE establishing a "Tony Smith Sculpture" account in the "General Donations and Gift Trust Fund," accepting donations thereto, and appropriating the same for the acquisition and installation of said sculpture.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That there is hereby established a "Tony Smith Sculpture" account in the "General Donations and Gift Trust Fund" to pay for the acquisition and installation of a large steel sculpture by Tony Smith, entitled "Moses", and donations received in the amount of Thirteen Thousand Dollars (\$13,000) together with such additional donations as may be made for such purpose shall be deposited in said fund and credited to said account and are hereby accepted and appropriated for such purpose, and the City Comptroller is authorized to draw and the City Treasurer to pay warrants against such account on vouchers approved by the Executive Secretary of the Seattle Arts Commission, all as contemplated by C.F. 278504.

(To be used for all Ordinances except Emergency.)

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
