ORDINANCE 103703

AN ORDINANCE relating to the Housing Rehabilitation Program, creating and establishing a Housing Rehabilitation Holding Fund, and authorizing expenditures therefrom.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. There is hereby established in the City Treasury a fund which shall be known as the Housing Rehabilitation Holding Fund of the City of Seattle, into which shall be placed all monies donated to the City for the purpose of rehabilitating substandard housing, and said monies shall be classified and segregated into the following two subaccounts within said fund:

Contributions - Banks


Contributions - Foundations and Others

Section 2. That upon the presentation of vouchers approved by the Mayor, the City Comptroller is authorized to draw and the City Treasurer to pay warrants on said fund established in Section 1 hereof.

Section 3. That any act pursuant to the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.


Section 4. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
