
AN ORDINANCE authorizing expenditure from the Judgment/Claims Fund to settle the claim of Municipality of Metropolitan Seattle (C-36865).

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:


Section 1. Upon presentation of a proper release, the City Comptroller is authorized to draw and the City Treasurer to pay a warrant in the amount of Fifteen Thousand Fifty-three Dollars and 72/100 (\$15,053.72). This sum constitutes the settlement and full satisfaction of the claim of Metro Transit for property damage sustained October 21, 1982, when the coach (articulated) was struck by a police vehicle at the intersection of N. 130th St. and Meridian Avenue N., as specified in Comptroller's File C-36865. The sum shall be paid from the Judgment/Claims Fund from sums heretofore appropriated for such purposes.

Section 2. This Ordinance, being an Ordinance required to allow a claim or appropriate money or other property to pay or satisfy the same, shall take effect and be in force immediately upon its approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become law under the provisions of the City Charter.



Dear Mr. Rice:

Submitted herewith is an ordinance appropriating the sum of \$15,053.72 from the Judgment/Claims Fund in full settlement and satisfaction of the claim Metro Transit. This is a claim presented by the authorized adjusting firm for the Municipality of Metropolitan Seattle (METRO). On October 21, 1982, our police vehicle wrongfully and negligently entered an intersection. A Metro articulated bus had the right-of-way and was well into the intersection. There is no evidence of any negligence by Metro. The high speed impact caused considerable damage to this German made bus. All labor and material repair costs are well documented.

We recommend this claim be paid.
