


BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:


Section 1. There is added to Seattle Municipal Code Section 6.212.070 (Ordinance 108934 § 6.150 as last amended by Ordinance 113613 § 8) a new subsection W as follows:

W. The taxicab owner or driver has been convicted of a crime while using a taxicab.

Section 2.... This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.



AN ORDINANCE amending Seattle Municipal Code Section 6.213.070 to add as ground for license suspension, revocation or denial of a taxicab vehicle license the use of the vehicle for crime.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. There is added to Seattle Municipal Code

Section 6.213.070 (Ordinance 108334 § 5.120 as last amended by Ordinance 113813 § 8) a new subsection W as follows:

W. The taxicab owner or driver has been convicted of a crime while using a taxicab.

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor, otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
