BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Section 1 of Ordinance 120408 is amended to read as follows:

Subsection A of the Seattle Municipal Code ((~~21.04.030~~)) 21.04.430, Ordinance 65877 as last amended by Ordinance 120178, is amended to read as follows:

SMC ((~~21.04.030~~)) 21.04.430 Rates inside City.

Section 2. Other than as shown in section 1 of this ordinance, Seattle Municipal Code section 21.04.430, as amended by section 1 of Ordinance 120408, remains in full force and effect.

Section 3. Any acts taken in furtherance of this ordinance, but prior to its effective date, are hereby ratified and confirmed.

Dear Council President Pageler:

Seattle Public Utilities respectfully requests the City Council's enactment of legislation to correct a typographical error in the water rate ordinance.

On June 11, the City Council approved Ordinance 120408 which added a third tier to the summer water rate. Due to a typographical error, Section 1 of Ordinance 120408 referred to Seattle Municipal Code Section "21.04.030" when it should have referred to "21.04.430". The attached ordinance corrects that error.

The earlier ordinance was clear in its intent and accurately reflected the rate structure chosen by the City Council. The current ordinance will place the rates in the appropriate section of the Municipal Code.




