BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:


SECTION 1. Payment of the sum of Seventeen Million, Four Hundred Ninety Two Thousand, One Hundred Fifty Five and 88/100 dollars (\$17,492,155.88) on Summit mechanical warrants numbered, 4001389380 - 4001392649, plus manual or cancellation issues for claims, and Electronic Financial Transactions (EFT) in the amount of Twenty One Million, One Hundred Eighty Three Thousand, Nine Hundred Ninety Nine and 72/100 dollars (\$21,183,999.72) are presented for ratification by the City Council per Chapter 42.23 RCW.


SECTION 2. Payment of the sum of Thirty One Million, Two Hundred Forty Five Thousand, One Hundred Five and 85 /100 dollars (\$31,245,105.85) on City General Salary Fund mechanical warrants numbered 51022582 -51024374 plus manual warrants, agencies warrants, and direct deposits numbered 270001 – 280716 representing Gross Payrolls for payroll ending date June 24, 2008 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council on July 3, 2008 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.


SECTION 3. That any act consistent with the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.

SECTION 4. This ordinance, being an ordinance required for the payment of salaries or current expenses shall take effect and be in force immediately upon its approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the City Charter.





