9 WHEREAS, capital and operating requirements of the Water Fund have increased in recent
10 years in response to security, environmental and infrastructure concerns, with a resulting
11 increase in the revenue requirements of the Water Fund; and

12 WHEREAS, demand for water service and new water installations have declined since water
13 rates were last modified, causing revenue shortfalls; and

14 WHEREAS, certain sections of the Seattle Municipal Code pertaining to water rates are
15 obsolete; and

16 WHEREAS, Seattle's retail water customers located within the areas of the former Richmond
17 Beach Water Company and former King County Water District No. 61 have reimbursed
18 Seattle Public Utilities for the costs of their respective acquisitions and resulting required
19 improvements, so that surcharges on these customers are no longer required; and

20 WHEREAS, the water rates authorized by this ordinance are consistent with the general
21 ratemaking policies set forth in Resolution 30742, adopted March 28, 2005; and

22 WHEREAS, credits for qualified low-income customers should be revised when water rates
23 change; NOW, THEREFORE,

24 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

25 **Section 1.** Seattle Municipal Code Section 21.04.420 is amended to read as follows:

26 **21.04.420 ((Temporary SurchARGE.)) Reserved**

1 ~~((A temporary surcharge of ten and two tenths percent (10.2%) will be added to the cost~~
2 ~~of water service supplied to residential and commercial customers for the period March 31, 2009~~
3 ~~through December 31, 2010.))~~

5 **Section 2.** Seattle Municipal Code Section 21.04.430 is amended to read as follows:

7 **21.04.430 Rates inside the City of Seattle**

8 All water used inside the City for domestic and commercial purposes shall be supplied by
9 meter only at the following rates and charges. Seasonal rates shall be prorated. For usage
10 representing fractional parts of a month, the base service charge and all components of the
11 commodity charge shall be prorated using a ~~((thirty-))~~30~~((-))~~-day month. The additional cost of
12 funding the Revenue Stabilization Subfund shall be specifically indicated in the billings. Seattle
13 Public Utilities shall continue to incorporate arts funding into its capital projects constructed
14 within the municipal boundaries of the City at the one ~~((1))~~percent level, however the
15 department shall not be permitted to fund any such program from the Water Fund on any capital
16 project outside the City limits.







Subject: **2012-2014 Water Rates: Final Committee Recommendations**

At its September 27, 2011 meeting, the SPUN Committee recommended passage of the proposed 2012-2014 water rates ordinance (C.B. 117232) with the following SPUN Committee recommended changes.

Issue#

- 1A. SPU-Proposed Base Service Reductions.** Accept the \$10.6 million in base service reductions that SPU incorporated into the rate proposal, unless those cuts are addressed elsewhere in this memorandum.
- 1B. Mismatch Between Rates and Proposed Budget.** Incorporate into rates the lower O&M costs for employee benefits, non-labor inflation and other O&M costs in the proposed 2012 budget, as well as any related adjustments in 2013 and 2014 costs. These costs will be \$1,732,000 (\$1.8 million minus the \$68,000 in CCSS savings in Issue 2C below)¹ less in the proposed 2012 budget than was assumed in the rate proposal.
- 1C. Further Base Service Cuts: Specific.** Incorporate into rates the O&M cuts in Issue 1D below.
- 1D/2D. Added Base and New O&M Reductions.** Reduce the rate revenue requirement by \$432,000 in 2012 and \$692,000 in 2013 to reflect: a) unfunding of 2 vacant Water Fund field FTEs with a savings of \$140,000/year in 2012 and beyond, b) reducing consulting funds that support business outreach, office workforce efficiencies, and environmental programs by \$292,000/year, and c) cutting \$260,000 in 2013 new O&M costs for Morse Lake Temporary Pumps (BIP 302) channel dredging and pump maintenance work, assuming that work will instead be funded as a base service.
- 1E. Workforce Efficiencies.** Make no change in the rate revenue requirement, but adopt a 2012 budget Statement of Legislative Intent (SLI) or budget proviso to provide the option of hiring an outside consultant to provide a perspective of

industry standards and other service delivery models in support of SPU's work group of employees and managers tasked with identifying how to most efficiently and effectively deliver field services.

- 2A. **Deferred Maintenance.** Include in the rate the additional deferred maintenance costs as proposed by SPU in the rate study and Budget Issue Paper (BIP) 101.
- 2B. **Watermain Condition Assessment.** Include in the rate the watermain condition assessment pilot project as proposed by SPU in the rate study and BIP 102.
- 2C. **Consolidated Customer Service System (CCSS) Purge.** Eliminate from the proposed 2012 rates \$68,000 for CCSS archiving and data purging. The proposed 2012 budget does not include this expense or its associated BIP 300.
- 2D. **Morse Lake Temporary Pumps (BIP 302).** See Issue 1D above.
- 2E. **Morse Lake Long-Term Pump Project Amortization of Deferred Costs.** Add to the revenue requirement \$1 million/year for amortization of deferred costs from a previous Morse Lake long-term pump capital project alternative.
- 2F. **Customer Care Billing System (BIP 402).** Eliminate from the proposed 2014 rates \$180,000 for customer care billing system improvements.
- 3A. **Capital Program Reductions.** Incorporate into rates the lower CIP costs in the proposed 2012 budget and 2012-2017 CIP, reducing spending by \$13.2 million in 2012, \$15.8 million in 2013 and \$23.8 million in 2014 as shown in Attachment B to Central Staff's September 13 water rates memorandum.
- 4A. **Demand Projections.** Change the employment growth used in SPU's demand models to 75% of the June 2011 Conway Pederson Puget Sound Economic Forecaster report estimate, instead of the 50% estimate assumed in proposed rates.
- 4B. **Tap Fees.** Reduce the rate revenue requirement by \$250,000 in 2013 and an additional \$250,000 (for a total of \$500,000) in 2014 to reflect more complete cost recovery from the tap fees. Pursue a 2012 budget SLI that directs SPU to update tap fees and work processes in 2012 so that the gap between yearly spending on new water taps and tap fee revenue is narrowed by those 2013 and 2014 amounts (\$250,000 and \$500,000 respectively). Include in the SLI a request that SPU report back to Council in 2012 before updating its tap fees and work processes.
- 4C. **Low-Income Emergency Assistance.** Change the SMC 21.76.065 emergency assistance eligibility threshold from 125% of the federal poverty level to a 70% of the state median income threshold, so that about twice as many low-income customers are eligible for once-a-year assistance in paying delinquent water, drainage, wastewater and solid waste bills.

4D. **City Utility Taxes.** Maintain current City utility tax rates as reflected in proposed water rates, and consider a tax change during a future rate period.

REVENUE, RATE AND BILL IMPACTS

The SPUN recommendations will reduce General Subfund revenues by \$60,000 compared to the amount assumed in the 2012 proposed budget. Impacts on proposed water rates and typical residential bills are:

COUNCIL APPROVAL PROCESS

On September 27 the SPUN Committee recommended that the proposed 2012-2014 water rate ordinance (C.B. 117232) be forwarded with Committee-recommended changes to the Full Council, with a request that the ordinance be re-referred to the Special Budget Committee. Re-referral will allow the Special Budget Committee to incorporate SPUN recommendations and make necessary amendments to reflect any additional Council changes to the proposed 2012 Budget. The amended ordinance would then be considered by Full Council in November as budget legislation.

City Clerk's Note: This memo that outlines the Seattle Public Utilities and Neighborhoods Committee's adopted amendments to Council Bill 117232 will represent version 5 of the Bill. The Special Budget Committee will review a version of the Bill with these amendments incorporated, along with the committee's amendments.

Legislation Title:

AN ORDINANCE relating to rates and charges for water services of Seattle Public Utilities; revising water rates and charges and amending Seattle Municipal Code Chapter 21.04 in connection therewith, removing Water District 61 and Richmond Beach Area meter surcharges and amending Seattle Municipal Code 21.12 in connection therewith, and revising credits to low-income customers and amending Seattle Municipal Code Chapter 21.76 in connection therewith.

Summary of the Legislation:

This ordinance would revise water rates for residential, general service, wholesale and public fire customers and adjust low-income assistance credits for water customers. This ordinance would increase rates to meet debt service coverage (DSC) requirements driven largely by past capital financing decisions, including debt restructuring and heavy debt reliance over the past 20 years for large capital projects.

Background:

(Include a brief description of the purpose and context of legislation and include record of previous legislation and funding history, if applicable.)

The cost of water services is supported by rates charged to water customers, which were last adopted by the City Council in 2008 for the period 2009 to 2011, and are set according to financial policies adopted by the City Council. Those rates were based on cost, revenue and demand assumptions from 2008. They did not account for the impacts of the economic downturn that ensued during the rate recovery period. The slowdown in the economy significantly impacted both water demand and new development, creating a revenue shortfall that is addressed in this water rate proposal.

In addition, current rates are not sufficient to provide the debt service coverage prescribed by SPU financial targets. Heavy debt reliance for large capital projects over the past 20 years along with a decision to replace variable rate debt with fixed rate debt in 2008 pushed DSC below the financial target of 1.7.

Dear Council President Conlin:

I am transmitting the attached proposed Council Bill and supporting rate study that would establish Seattle Public Utilities' (SPU's) water rates for the period 2012-2014. This water rate package funds investments in the supply and distribution of safe, pure water for Seattle residents and wholesale customers throughout the region, complies with regulatory requirements, and promotes continued conservation.

The proposed rates are necessary to cover SPU's cost of operations and would increase the typical monthly residential water bill by \$2.41 in 2012, \$2.68 in 2013 and \$2.91 in 2014. Since water rates were last adopted in 2008, the slowdown in the economy significantly impacted both water demand and new development, creating a revenue shortfall that is addressed in this water rate proposal. In addition, by City policy, the Water Fund's annual revenues after operating and maintenance costs need to exceed debt service obligations by 1.7 times. While placing upward pressure on SPU's rates, this prudent policy helps SPU receive high credit ratings and sell bonds to fund infrastructure investments at the lowest possible cost. Debt service payments are associated with several major capital investments made during the past decade, including water treatment facilities on the Tolt and Cedar Rivers, coverings for five open reservoirs, and investments to meet federal requirements embodied in the Cedar River Watershed Habitat Conservation Program. These investments will benefit ratepayers for years to come.

To help minimize rate increases while still complying with regulations and financial policies, SPU reduced its budget significantly between 2009 and 2011, removing 85 FTE across the department and curtailing other expenses. As a result, this rate study is able to propose capital and operating expenditures for 2012 that are lower than amounts assumed for 2011 in the 2009-2011 rate study.

The proposed rates will strengthen the financial health of the Water Fund and allow SPU to continue providing pure drinking water to Seattle residents and wholesale customers at less than a penny a gallon. Legislation Title:

AN ORDINANCE relating to rates and charges for water services of Seattle Public Utilities; revising water rates and charges and amending Seattle Municipal Code Chapter 21.04 in connection therewith; removing Water District 61 and Richmond Beach Area meter surcharges and amending Seattle Municipal Code 21.12 in connection therewith; and revising credits to low-income customers and amending Seattle Municipal Code Chapter 21.76 in connection therewith.

Summary of the Legislation:

This ordinance would revise water rates for residential, general service, wholesale and public fire customers and adjust low-income assistance credits for water customers. This ordinance would increase rates to meet debt service coverage requirements driven largely by past capital financing decisions, including debt restructuring and bonds issued over the past 20 years to build major capital projects to meet regulatory requirements and ensure an adequate supply of pure water for generations.

Background:

The cost of water services is supported by rates charged to water customers, which were last adopted by the City Council in 2008 for the period 2009 to 2011, and are set according to financial policies adopted by the City Council. Those rates were based on cost, revenue and demand assumptions from 2008. They did not account for the impacts of the economic downturn that ensued during the rate recovery period. The slowdown in the economy significantly impacted both water demand and new development, creating a revenue shortfall that is addressed in this water rate proposal.

A significant increase in revenues is required to meet the Water Fund's debt service coverage financial policy target by the end of 2014. This is the result two primary factors. This first is debt service associated with major capital projects including water treatment facilities on the Tolt and Cedar Rivers, coverings for five open reservoirs due to federal regulations, and investments to meet federal requirements embodied in the Cedar River Watershed Habitat Conservation Program. The second is the 2008 decision to replace Water Fund variable rate debt with fixed rate debt in response to financial market volatility. While this decision was an effective response to financial volatility, it had the effect of increasing the amount of senior lien debt and thereby lowering actual debt service coverage below the policy target of 1.70.



A complete description of the 2012-2014 rate package is contained in the 2012-2014 Water Rate Study, which is attached to this fiscal note.

Additional Water Fund revenue of \$19.2 million reflects the combined effect of the proposed legislation applied to current demand forecasts of retail, general service, wholesale, and public fire (hydrant) demand, as compared to that same demand at 2011 rates. Because these customer classes are discussed in various sections of the attached 2012-2014 Water Rate Study, this \$19.2 million does not appear in one location in the document. The 2012-2014 Water Rate Study also proposes 2013 and 2014 rates, which, when applied to the current demand forecast, will increase 2013 and 2014 revenues \$33,941,765 and \$50,032,362, respectively, over current law.

As described above, this legislation proposes rates for the following three years and makes long term capital investments in the water system to ensure a safe supply of water and meet regulatory requirements.

- b) **What is the financial cost of not implementing the legislation?**

The Water Fund would not fully recover the cost of its business operations and meet its financial policy targets. This could result in a downgrade in the Fund's bond ratings and increase the cost of borrowing in the future.

- c) **Does this legislation affect any departments besides the originating department?**

Several City departments have facilities that incur water costs. The water fees for these departments will increase commensurate with the rate increases proposed in this legislation. The impacts will be included in the 2012 Proposed Budget. The impacted



departments include: Seattle Center, the City Budget Office, Seattle City Light, the Department of Neighborhoods, the Seattle Department of Transportation, the Seattle Fire Department, the Department of Finance and Administrative Services, the Department of Parks and Recreation, the Seattle Police Department, Seattle Public Utilities, and the Seattle Public Library.

d) What are the possible alternatives to the legislation that could achieve the same or similar objectives?

Not raising the rates at this time would result in the Water Fund failing to recover the cost of its operations and to meet its financial policies. Alternatively, the Water Fund could meet its financial policies without raising rates by cutting the cost of its operations by the amounts shown above; however, this would result in an inability to pay for basic operations or make important investments in the water system.



AN ORDINANCE relating to the Department of Parks and Recreation; establishing the 2012 fee schedule for the use of park properties and other park and recreation facilities and services; superseding previous park and recreation fee schedules; and amending Section 18.28.010 of the Seattle Municipal Code.

ORDINANCE NO. 123760

AN ORDINANCE amending the 2011 Budget, including the 2011-2016 Capital Improvement Program (CIP); changing appropriations to various departments and budget control levels, and from various funds in the Budget; revising project descriptions; revising project allocations for certain projects in the 2011-2016 CIP; making cash transfers between various city funds; creating new appropriations, amending ordinances 123442 and 123664; and ratifying and confirming certain prior acts; all by a 3/4 vote of the City Council.

ORDINANCE NO. 123761

AN ORDINANCE relating to the Alaskan Way Viaduct and Seawall Replacement Program; authorizing the creation of a City fund; and authorizing the loan of funds from the City's Consolidated (Residual) Cash Pool, or its participating funds, to the new fund.

ORDINANCE NO. 123762

AN ORDINANCE relating to the levy of property taxes; fixing the rates and/or amounts of taxes to be levied, and levying the same upon all

taxable property, both real and personal, in The City of Seattle, to finance the departments and activities of City government and to provide for the general obligation bond interest and redemption requirements for the year beginning on the first day of January 2012; and ratifying and confirming certain prior acts.

ORDINANCE NO. 123763

AN ORDINANCE authorizing the levy of regular property taxes by The City of Seattle for collection in 2012, representing an increase above the regular property taxes levied for collection in 2011; and ratifying and confirming certain prior acts

ORDINANCE NO. 123764

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.
