13 WHEREAS, the projects identified in this legislation are consistent with the objectives of the
14 Seattle Urban Area Strategy, as approved by the Federal Department of Homeland
15 Security; and

16 WHEREAS, Ordinance 121283, passed by the City Council on September 22, 2003, authorized
17 the Seattle Police Department to apply for funding under FFY03 UASI Grant Award
18 Programs I and II, authorized the Seattle Police Department to execute an agreement to
19 partner with the State of Washington, King County, and other local jurisdictions to
20 participate in UASI Grant Award Program II, and appropriated an initial allocation of
21 funding under both grant programs for immediate needs of conducting vulnerability
22 assessments and providing urgently needed equipment to City departments; and

23 WHEREAS, Ordinance 121418 passed by the City Council on March 15, 2004, authorized the
24 Seattle Police Department to apply for the remaining funding available through Federal
25 Fiscal Year 2003 UASI Grant Award Programs I and II; and

26 WHEREAS, Ordinance 121515, passed by the City Council on June 28, 2004, authorized the
27 Seattle Police Department to apply for funding under UASI FFY04; and

28 WHEREAS, Ordinance 121860, passed by the City Council on July 11, 2005, authorized the
Seattle Police Department to apply for additional funding under UASI FFY05; and

WHEREAS, Ordinance 122348, passed by the City Council on February 26, 2007, authorized
the Seattle Police Department to apply for additional funding under UASI FFY06; and

WHEREAS, Ordinance 122633, passed by the City Council on February 25, 2008, authorized
the Seattle Police Department to apply for additional funding under UASI FFY07; and



1 WHEREAS, Ordinance 122886, passed by the City Council on December 15, 2008, authorized
the Seattle Police Department to apply for additional funding under UASI FFY08; and

2 WHEREAS, Ordinance 123196, passed by the City Council on December 7, 2009, authorized
3 the Seattle Police Department to apply for the additional funding under UASI FFY09;

4 WHEREAS, Ordinance 123551, passed by the City Council on February 28, 2011, authorized
5 the Seattle Police Department to apply for the additional funding under FFY10;

6 WHEREAS, Ordinance 123930, passed by the City Council on July 23, 2012, authorized the
7 Seattle Police Department to apply for the additional funding under FFY11; and

8 WHEREAS, the projects to be funded by UASI FFY12 were identified using a thorough process
9 that involved operations staff from two City departments, including the Seattle Police
Department and Seattle Fire Department.

10 NOW, THEREFORE,

11 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

13 Section 1. The Chief of Police or his designee is authorized to partner with the State of
14 Washington and King County to receive financial assistance from DHS, and execute all
15 documents he reasonably deems necessary for the application and receipt of Federal Fiscal Year
16 2012 UASI funds in the amount of \$1,645,955 to address the unique equipment, training, and
17 planning needs of the Seattle Urban Area to prevent, respond to, and recover from threats or acts
18 of terrorism. These funds are hereby accepted and shall be deposited in the funds named in
19 Section 2 to reimburse for appropriations made in Section 2.

20 Section 2. To carry out the purpose of the agreements authorized in Section 1 during the
21 2014 fiscal year, and contingent upon the execution of those agreements, appropriation authority
22 in the Seattle Police Department and the Seattle Fire Department is increased as follows:

1 Unspent funds so appropriated shall carry forward to subsequent fiscal years until they
2 are exhausted or abandoned by ordinance.

3 Section 3. Any act made pursuant to the authority of this ordinance taken prior to the
4 effective date of this ordinance is hereby ratified and confirmed. If any provision of this
5 ordinance is determined to be invalid or unenforceable the remainder shall nonetheless remain in
6 full force and effect.


7 Section 4. This ordinance shall take effect and be in force 30 days after its approval by

9 shall take effect as provided by Seattle Municipal Code Section 1.04.020.





Legislation Title: AN ORDINANCE relating to security from terrorism; authorizing the City to partner with the State of Washington and King County to receive financial assistance from the Department of Homeland Security (DHS), Office for State and Local Government Coordination and Preparedness under the Urban Areas Security Initiative Grant for Federal Fiscal Year 2012; authorizing an application for allocation of funds under that agreement; amending the 2014 Adopted Budget Ordinance 124349 by increasing appropriations to the Seattle Police Department and Seattle Fire Department and accepting revenues; and, ratifying and confirming prior acts, all by a three-fourths vote of the City Council.

Summary of the Legislation:

This legislation receives revenue from the Department of Homeland Security (DHS) from the Urban Area Security Initiative (UASI) Grant for Federal Fiscal Year 2012 (FFY12) and appropriates a total of \$1,645,955 to the Seattle Police Department and Seattle Fire Department. UASI FFY12 will reimburse the City of Seattle for equipment, training, exercise, planning and management needs associated with preventing, responding to, and recovering from, threats or acts of terrorism.

This legislation additionally authorizes the Seattle Police Department to execute an agreement to partner with the State of Washington, King County, and other local jurisdictions to participate in UASI FFY12 and receive funding from the state.

Background:

This is the tenth ordinance the Seattle Police Department has requested City Council acceptance related to funds from DHS for furthering the City's emergency preparedness strategy. Seattle was one of seven cities awarded funding through the UASI Grant Award Program I and one of thirty urban areas awarded funding in Grant Award Program II, both in 2003. Since then, Seattle has continued to utilize this funding each year as available to enhance its emergency preparedness strategies.

Below is a list of the prior Ordinances related to this grant:

- Ordinance 121283 (September 22, 2003) and Ordinance 121418 (March 15, 2004) authorized the Seattle Police Department to apply, where applicable, for funding from these grants;
- Ordinance 121515 (June 28, 2004) authorized additional funding under Federal Fiscal Year 2004;
- Ordinance 121860 (July 11, 2005) authorized funding under Federal Fiscal Year 2005;



- Ordinance 122348 (February 26, 2007) authorized funding under Federal Fiscal Year 2006;
- Ordinance 122633 (February 25, 2008) authorized funding under Federal Fiscal Year 2007;
- Ordinance 122886 (December 15, 2008) authorized funding under Federal Fiscal Year 2008;
- Ordinance 123196 (December 7, 2009) authorized funding under Federal Fiscal Year 2009;
- Ordinance 123551 (February 28, 2011) authorized funding under Federal Fiscal Year 2010; and,
- Ordinance 123930 (July 23, 2012) authorized funding under Federal Fiscal Year 2011.

Funding authorized by this legislation is used for purchases and programming that reflects a multi-disciplinary approach which recognizes the need for prevention, protection, and response capability. Utilization of previous grants by Seattle Police and Fire Departments and Seattle Urban Area partners have resulted in the development of risk assessments for Seattle, strategies to respond to those risks, and funding to implement those strategies. UASI FFY12 will continue funding to provide first responders with the training and equipment necessary to mitigate ever-evolving threat scenarios, as well as assist in evaluating the effectiveness of Homeland Security funding. Funds received from this grant will also provide additional interoperable communication equipment and training for enhance communication with urban area partners such as King County.

This grant will be used for the following types of expenditures in 2014:

- Sustainment of program and Fusion Center operations;
- Continuance of citizen preparedness campaigns;
- Provision of law enforcement training and exercises focused on chemical, biological, radiological, nuclear, and explosive (CBRNE) topic areas;
- Continued work on the regional Booking Photo Comparison software system in collaboration with King County;
- Purchase of structural collapse response equipment;
- Provision of WMD/structural collapse training;
- Purchase of CBRNE equipment including PPE Class 2 rescue suits; and
- Continuation of a vulnerable population planning position.

Other Implications:

- a) **Does the legislation have indirect financial implications, or long-term implications?**
At this time, any sustainment issues with purchased equipment are addressed within existing budget resources of the recipient departments. However, this legislation funds items and positions that may in the future need to be replaced or continued with other funding should the grant funding not be available and Seattle wish to continue the services. At this time, there is no foreseeable end to this grant funding.
- b) **What is the financial cost of not implementing the legislation?**
Not implementing the legislation would result in the loss of funding that has been made available to the City under Federal Fiscal Year 2012 UASI. This would result in significantly less capacity to improve the City's overall ability to prevent, respond to, and recover from threats or acts of terrorism. In addition, not implementing this legislation would likely result in the City of Seattle and contiguous jurisdictions being ineligible to receive future funding that is expected to be made available under later phases of the UASI Grant Program.

PROJECT #1 UASI Program M&A and Sustainment

Project Description:

Manage and sustain UASI program for City of Seattle

PROJECT #2 Structural Collapse Equipment – Shoring / Cribbing

Project Description:

The need to respond to and recover from a potentially catastrophic structural collapse incident is consistent with the Urban Area's Threat and Vulnerability Analysis. This investment significantly enhances CBRNE response capability by equipping first-responders throughout the UASI Region to operate effectively and safely at an advanced CBRNE/Structural Collapse incident as a result of a natural or man-made catastrophic incident and enhancing search and rescue (SAR) capabilities. This investment represents a progression in the development of the SAR response capability throughout the UASI by enhancing interoperability SAR capabilities by standardizing equipment throughout the Seattle UASI allowing for standardized multijurisdictional response. The will provide the necessary equipment to sustain SAR without delay when needed most, immediately after an incident occurs during the initial response. The requested investment will allow regional agencies to begin the life saving process during the Response Mission safely prior to the arrival of additional resource. This project provides structural collapse equipment to build capability throughout the UASI This equipment is all verified on the Authorized Equipment List and vetted as interoperable with the Washington State Equipment Committee. This investment will be evenly distributed amongst the three counties with exception of the Holmatro Combi-Tool 3120 which will be split evenly between Pierce and Snohomish Counties and the Heavy Rescue Response Vehicle which will be provided for Pierce County. Training has been, and will continue, provided to the region in use and operation of the equipment being requested.

PROJECT #3 Vulnerable Populations

Project Description:

The Vulnerable Populations / Whole Community planner will identify and address gaps in current regional emergency notification and warning systems, specifically as they apply to vulnerable populations groups.

PROJECT #4 UASI Regional Component of WA State Fusion Center

Project Description:

This project will provide the funds to sustain the substantial UASI regional programs that are part of the Fusion System and at the Fusion Center. These programs include information sharing networks, intake and dissemination systems, ongoing planning and support, and most significantly a regional cadre of analysts consisting of: a Regional Lead Analyst, and seven Analysts (the Northern UASI, Eastern UASI and Central UASI/Intake Analysts, CBRNE/Fire Fusion and Health Analyst, Gang Analyst, Critical Infrastructure/Private Sector Analyst, and Regional DT/IT Analyst) through approximately February 2014 with the associated regional SHSP funds. It will also address the UASI portions of the Fusion Center's related equipment and training needs. It will also support the completion of information sharing networks, analytical and first responder training, completion of the fusion liaison program, ongoing training and sustainment of the regional analysts, etc. Intelligence analyst training will focus on homeland security trends, analytical techniques, privacy, and civil liberties.

PROJECT #5 Citizens Preparedness & Outreach (Whole Community)

Project Description:

Under the Whole Community preparedness umbrella, this project funds ongoing community activities in the five UASI partner jurisdictions which maintain and enhance their jurisdiction's public education program. While each of the jurisdictions uses the same basic messages of preparedness, the demographics of each jurisdiction require flexibility on how the messages are delivered and who the target audience is for that jurisdiction. This funding proposal allows for a regional approach to community and personal preparedness while also building capacity for each jurisdiction to provide programs to populations that are inherently more vulnerable in disasters from terrorism or natural causes. The Public Education UASI subcommittee meets on a regular basis during the year to coordinate activities and to collaborate. Each jurisdiction will continue to build awareness and motivate people to take action toward being prepared, through the creation of marketing materials such as brochures, teaching tools, and translated materials that can be printed for distribution in programs and at community gathering places. Funding may also be used to modify existing and new products so that they are in keeping with changes in technology such as web postings, video training, and surveying levels of preparedness using web based surveying



tools. To expand programs into audiences more difficult to reach, funding may be used to pay for interpreters, purchase advertising, and hiring of consultants or contractors to assist in program design and delivery. We are working together to leverage our resources to be able to participate in Puget Sound area mass media campaigns like the What If Expo (KOMO), 3 To Get Ready (KIRO), Take Winter by Storm, etc.

PROJECT #6 Law Enforcement Training and Drills

Project Description:

This project proposes additional investment in multiple shooter, terrorism response, CBRNE, and counter terrorism training and drills for specialty teams. The training and drills will include law enforcement from all partner jurisdictions and include Demonstration Management/Crowd Control, CBRNE Warm Zone operations, Critical Infrastructure Protection and All Hazards Response. Training will be directed towards addressing training shortfalls of individuals and units up to the platoon level. Training and drills will be conducted in both classroom and field environments as appropriate.

PROJECT #7 WMD/Structural Collapse Rescue Training

Project Description:

The need to respond to and recover from a potentially catastrophic structural collapse incident is consistent with the Urban Area's Threat and vulnerability analysis. This investment significantly enhances CBRNE response capability by training first-responders to operate effectively and safely at an advanced WMD CBRNE incident as a result of an IED/WMD. It will provide regional training and exercises as follows:

1. This project provides WMD Structural Collapse Rescue Training (SCT) at the technician level to responders (firefighters) in the UASI to build the cadre throughout the region. The project is for (2) course deliveries, 24 students per delivery, for a total of 48 students. This investment will cover the pre-course mobilization, instructor backfill/overtime (BF/OT), participant BF/OT, and post-course demobilization. The delivery of the course will be conducted over a three week period with one week of training, one week with no delivery followed by the second delivery of instruction the last week. This will assist will reducing mobilization and demobilization cost.
2. This project provides CBRNE training at the hazmat technician level to responders (firefighters) in the UASI to enhance capability through the region. This project will allow hazmat technicians to attend DHS sponsored training, providing backfill/overtime. This will include several iterations of the HazMat IQ course and attendance at DHS Training Consortium sponsored training.
3. This project provides a Mass Transit Multi-disciplinary Full-scale Exercise with a focus on validating equipment and training procurements from the previous two grant cycles and spanning several grants within the HSGP, to include UASI, SHSP.
4. This investment will provide the drills and equipment for a High-Rise Rapid Insertion Team (H-RIT) for the region to perform citizen evacuation in high-rise buildings and other areas that are difficult to access as well as insert firefighters for firefighting activities. It will provide the Fire Service with the necessary equipment to equip one six-person HRIT's and the necessary training to safely operate in an aviation environment. Equipment purchased will be the minimum safety equipment identified by the Aviation Sub- Committee to safely operate in the aviation environment. Drills will consist of quarterly training sessions, each approximately 10 hours in duration for a total of 12 fire service personnel. These personnel could be utilized as a regional asset via current mutual aid agreements.

PROJECT #8 CBRNE Equipment – PPE Class 2 Rescue Suits

Project Description:

This Continuation project of equipment for WMD/HazMat Detection, heavy rescue US&R, personal protection, communications, and pre-hospital triage, treatment and transport for survivors will provide necessary equipment for the first responder community. All equipment is eligible for purchase under the UASI Grant Program via Authorized equipment List. The goal for this investment is to build interoperable capabilities throughout the UA. This investment builds off of previous UASI investments and is partnered with the Fire/EMS/HazMat training & exercise proposals, previous and current submittal, and was vetted by the committee which is comprised of representatives from the three counties and two cities represented by the UA.

PROJECT #9 Booking Photo Comparison Software System

Project Description:

There currently exists an opportunity to utilize an existing established AFIS King County Data Base of 667,000 potential images, and an advanced comparison software technology. Combining these two types of resources would create an advanced

search engine to support the investigative needs of Detectives and Officers of both county and municipal agencies. This program will help to increase the effectiveness of all law enforcement personnel to help identify digital images of currently unknown suspects when those images are available and of comparison value. There is potential to tie into larger regional Data Bases such as Pierce County, Snohomish County and the Washington State Patrol. This Booking Photo Comparison search engine has the potential to also draw on much larger Law Enforcement data bases such as Linx, (Law Enforcement Information Exchange utilizing a larger region such as California, Oregon, Idaho, Montana, Nevada and Alaska) this would allow access to millions of potential suspect candidates.

AN ORDINANCE relating to the University Heights Center for the Community Association, authorizing the execution of amendments to both the Agency Service Agreement and Restrictive Covenant established by City Council Ordinance 123016 adopted on June 24th, 2009 changing and aligning the use requirements for the University Heights Center set forth in both documents.

AN ORDINANCE relating to land use and zoning, extending the effect of interim development regulations previously extended by Ordinance 124269 to prohibit incompatible buildings on undersized single-family-zoned lots, and declaring an emergency requiring a three-fourths vote of the City Council so that the ordinance may take effect immediately.

ORDINANCE NO. 124438

AN ORDINANCE relating to security from terrorism; authorizing the City to partner with the State of Washington and King County to receive financial assistance from the Department of Homeland Security (DHS), Office for State and Local Government Coordination and Preparedness under the Urban Areas Security Initiative Grant for Federal Fiscal Year 2012; authorizing an application for allocation of funds under that agreement; amending the 2014 Adopted Budget Ordinance 124349 by increasing appropriations to the Seattle Police Department and Seattle Fire Department and accepting revenues; and, ratifying and confirming prior acts, all by a three-fourths vote of the City Council.

AN ORDINANCE related to Orion O. Denny Park; authorizing the Superintendent of Parks and Recreation to enter into an operation and maintenance agreement with the City of Kirkland for Orion O. Denny Park.

ORDINANCE NO. 124440

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.
