COUNCIL BILL 118283

AN ORDINANCE authorizing, in 2014, acceptance of funding from non-City sources; authorizing the heads of the Executive Department, Department of Information Technology, Department of Neighborhoods, Seattle Fire Department, Seattle Police Department, Seattle City Light and the Seattle Department of Transportation to accept specified grants and private funding and to execute, deliver, and perform corresponding agreements; and ratifying and confirming certain prior acts.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. The Mayor or his designees, the Chief Technology Officer, the Director of the Department of Neighborhoods, the Fire Chief, the Chief of Police, the General Manager & Chief Executive Officer of Seattle City Light and the Director of Transportation, are authorized to accept the following non-City funding from the grantors listed below, and to execute, deliver, and perform on behalf of The City of Seattle, agreements for the purposes described below. The funds, when received, shall be deposited in the receiving fund identified below to support, or as reimbursement for, the corresponding appropriations set forth in the ordinance introduced as C.B. 118284.

This program supports regional security initiatives that include cyber detection and prevention of cyber terrorism activities. This funding provides for acquisition of various cyber security software and equipment to support the Public Regional Information Security Event Management (PRISEM) project. The equipment will be used to collect and analyze data from the region. The grant ended on August 30, 2014. This grant does not require any match.	
1.3	OJJDP FY 2014 National Forum on Youth Violence Prevention Expansion Project (Department of Neighborhoods, General Subfund (00100))	\$20,000
	This item accepts grants in the amount of \$20,000 to the Youth Violence Prevention BCL from the U.S. Department of Justice. I am pleased to transmit the attached proposed Council Bill, which accepts grants and private funds from various agencies and organizations. Corresponding appropriations for items in Section 1 of this Council Bill are included in the City Budget Office's 2014 Fourth Quarter Supplemental Ordinance, which is being transmitted to the Council under separate cover. This Bill accepts fifty-one grants or private funds totaling \$11,796,400 on behalf of seven City departments. A few of these grants are noted below:

Executive / OED & OCR: Five grants totaling approximately \$600,000. A Seattle Foundation grant to Office of Economic Development (OED) will be used to invest in five neighborhood business districts adjacent to the Yesler Terrace housing redevelopment project. OED will use another grant from various regional groups to launch a regional Green Business Program that will efficiently and effectively deliver green business services to the region's businesses. An Office for Civil Rights grant from the U.S. Department of Housing and Urban Development provides resources for training and outreach work on fair housing and anti-discrimination.

Seattle Fire Department: Fifteen various grants totaling \$4.4 million. The majority of the grant money is from the U.S. Department of Homeland Security and provides funds for equipment and training related to the prevention and responding to mass casualty situations.

Seattle Police Department: Nineteen various grants totaling \$2.8 million. Over \$800,000 comes from the U.S. Department of Justice and provides funding to maintain and expand the existing Northwest Regional Internet Crimes Against Children Task Force, as well as resources for pursuing gang activity, apprehending violent fugitives, and the investigation of drug cases.

Seattle Department of Transportation: Three grants totaling \$3.5 million. \$3.4 million from the Puget Sound Regional Council will be used to mill and overlay approximately 2.7 miles of roadways and also to purchase and install at least four bike share stations to serve low-income populations.

AN ORDINANCE authorizing, in 2014, acceptance of funding from non-City sources; authorizing the heads of the Executive Department, Department of Information Technology, Department of Neighborhoods, Seattle Fire Department, Seattle Police Department, Seattle City Light and the Seattle Department of Transportation to accept specified grants and private funding and to execute, deliver, and perform corresponding agreements; and ratifying and confirming certain prior acts.

Summary of the Legislation:

This Council Bill proposes the acceptance of 51 grants and/or private funds from various agencies and organizations.

Background:

During the course of a year, City departments receive grant awards or opportunities for other funding resources that are not anticipated in the Adopted Budget. 


