**CITY OF SEATTLE**

**ORDINANCE** 125148

**COUNCIL BILL** 118811

AN ORDINANCE relating to City employment; amending Section 4.04.030 of the Seattle Municipal Code; authorizing a Memorandum of Understanding between The City of Seattle and certain City unions; and ratifying and confirming certain prior acts.

WHEREAS, The City is currently engaged in several large projects such as the Summit Re-Implementation project in multiple City departments, and the New Customer Information System at City Light and Seattle Public Utilities; and

WHEREAS, regularly appointed employees need to be and have been assigned to these projects for continuity of operations after the projects complete; and

WHEREAS, term-limited temporary workers are performing the “regular” body of work of regularly appointed employees who are assigned to these projects; and

WHEREAS, the Seattle Municipal Code and many collective bargaining agreements with City labor unions limit the conditions under which term-limited temporary work may be assigned; NOW, THEREFORE,

**BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

Section 1. Seattle Municipal Code Section 4.04.030, last amended by Ordinance 124567, is amended as follows:

\* \* \*

35. “Temporary worker” includes both temporary and less than half time employees and means a person who is employed in:

a. an interim assignment of up to one year to a vacant regular position to perform work associated with a regularly budgeted position that is temporarily vacant and has no incumbent; or

1 b. an interim assignment for short-term replacement of a regular employee of up to one year  
2 when the incumbent is temporarily absent; or

3 c. a short-term assignment of up to one year, which may be extended beyond one year only  
4 while the assignment is in the process of being converted to a regular position, to perform work  
5 that is not ongoing regular work and for which there is no regularly budgeted position; or

6 d. a less than half-time assignment for seasonal, on-call, intermittent or regularly scheduled  
7 work that normally does not exceed 1,040 hours in a year, but may be extended up to 1,300 hours  
8 once every three years and may also be extended while the assignment is in the process of being  
9 converted to a regular position; or

10 e. a term-limited assignment for a period of more than one but less than three years for time-  
11 limited work related to a specific project, grant or other non-routine substantial body of work((  
12 or)); for the replacement of a regularly appointed employee when that employee is absent on long-  
13 term disability time loss, medical or military leave of absence; or for the replacement of a  
14 regularly appointed employee who is assigned to special time-limited project work.

15 For purposes of administering temporary assignments, one year shall be equivalent to 26  
16 consecutive pay periods. The Seattle Human Resources Director may promulgate rules that direct  
17 departments to limit temporary assignments to fewer hours than this ordinance provides for.

18 Except as may be provided by ordinance or labor contract, temporary workers shall be exempt  
19 from the provisions of this ((title)) Title 4.

22 Section 2. The Mayor is authorized on behalf of The City of Seattle (“City”) to execute a  
23 Memorandum of Understanding between the City and certain City labor unions, substantially in

1 the form attached to this ordinance as Attachment 1 and identified as “Memorandum of  
2 Understanding By and Between City of Seattle And Certain City Unions.” The Memorandum of  
3 Understanding between the City and those labor unions amends existing collective bargaining  
4 agreements to make them consistent with Seattle Municipal Code subsection 4.04.030.35.

5 Section 3. Any act consistent with the authority and prior to the effective date of this  
6 ordinance is ratified and confirmed.


1 Section 4. This ordinance shall take effect and be in force 30 days after its approval by  
2 the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it  
3 shall take effect as provided by Seattle Municipal Code Section 1.04.020.



MEMORANDUM OF UNDERSTANDING

By and Between

CITY OF SEATTLE

And

CERTAIN CITY UNIONS

This Memorandum of Understanding (“MOU”) is entered into between the City of Seattle (“City”) and the unions signatory to this MOU (“Unions”). Collectively, the City and the Unions shall be known as “the Parties.”

1. Most collective bargaining agreements contain provisions defining a temporary worker and limiting the conditions under which temporary work may be assigned. For “term-limited” temporary assignments, the parties agree to amend their collective bargaining agreements to remove the existing provision describing the conditions under which term-limited work may be assigned and replace it with the language in Section 2 of this MOU.

*The terms temporary employee and temporary worker shall be defined to include both temporary and less than half time employees and means a person who is employed in: ...*

2. *a term-limited assignment for a period of more than one but less than three years for time-limited work related to a specific project, grant or other non-routine substantial body of work; for the replacement of a regularly appointed employee when that employee is absent on long-term disability time loss, medical or military leave of absence; or for the replacement of a regularly appointed employee who is assigned to special time-limited project work.*
3. Unions signatory to this MOU whose collective bargaining agreements do not contain provisions related to term-limited temporary work but who represent temporary workers agree to the conditions of assigning term-limited temporary work provided in Section 2 of this MOU.



### Ordinance 125134

AN ORDINANCE relating to land use and zoning; amending Chapter 23.32 of the Seattle Municipal Code at page 112 of the Official Land Use Map to rezone property located at 2220 East Union Street from Neighborhood Commercial 2-40 (NC2-40) to Neighborhood Commercial 2-65 (NC2-65) and from Neighborhood Commercial 2-40 with a pedestrian designation (NC2P-40) to Neighborhood Commercial 2-65 with a pedestrian designation (NC2P-65); and accepting a Property Use and Development Agreement as a condition of rezoning approval (Petition by East Union 22, LLC, C.F. 314312, SDCI Project 3019001)

### Ordinance 125138

AN ORDINANCE relating to the Seattle Fire Code, adopting as the Seattle Fire Code the 2015 edition of the International Fire Code with some exceptions, amending and adding various provisions to that code; amending Section 22.600.020 of the Seattle Municipal Code; and repealing Sections 2 through 44 of Ordinance 124288.

### Ordinance 125139

AN ORDINANCE relating to Seattle Public Utilities; authorizing the Director of Seattle Public Utilities to accept on behalf of The City of Seattle the transfer of approximately 165 acres of forest land in the North Fork Tolt River Watershed from Forterra and to acquire approximately 100 acres of forest land located adjacent to the Forterra property and the South Fork Tolt Municipal Watershed owned by the City.

AN ORDINANCE related to Seattle Public Utilities; authorizing the Director of Seattle Public Utilities to enter into an Interlocal Agreement with the Port of Seattle to serve as an operating agreement between Seattle Public Utilities and the Port of Seattle Drainage Utility including code modifications to exclude all Port-owned properties from the requirement to pay City stormwater and drainage fees; terminating the 1997 stormwater credit from the City to the Port; accepting a settlement payment from the Port of Seattle; containing details related to ownership and maintenance of infrastructure, authorities and responsibilities, system interconnections, access, coordination and dispute resolution; amending Section 21.38.030 of the Seattle Municipal Code; and ratifying and confirming certain prior acts

AN ORDINANCE relating to Seattle Public Utilities; authorizing the Director of Seattle Public Utilities to accept a loan from the Washington State Public Works Board and to execute, deliver, and perform corresponding agreements; and ratifying and confirming certain prior acts.

AN ORDINANCE granting Swedish Health Services permission to construct, maintain, and operate a pedestrian sky-bridge over and across Minor Avenue, between Columbia Street and Cherry Street, for a ten-year term, renewable for two successive ten-year terms; specifying the conditions under which this permit is granted; and providing for the acceptance of the permit and conditions.
