3 A RESOLUTION declaring the City of Seattle will support the Capitol Hill EcoDistrict as a
4 framework and agent for advancing City sustainability goals within the EcoDistrict
5 boundaries.

6 WHEREAS, the City has outlined an ambitious sustainability agenda in City-wide documents,
7 including the Seattle Comprehensive Plan, Climate Action Plan, Bicycle Master Plan,
8 Pedestrian Master Plan, Solid Waste Management Plan, Cultural Overlay District
9 Advisory Committee recommendations, Water Efficiency Master Plan, Zero Waste
10 Resolution, and Urban Forest Stewardship Plan; and

11 WHEREAS, The City is a founding member and active partner in achieving the targets of the
12 Seattle 2030 District; and

13 WHEREAS, neighborhoods are critical partners in the formation and local implementation of
14 sustainability strategies to meet the goals articulated in City plans and the 2030 District;
15 and

16 WHEREAS, the Capitol Hill EcoDistrict is the first official EcoDistrict to be established in the
17 City of Seattle; and

18 WHEREAS, the Capitol Hill EcoDistrict provides a model for pursuing City sustainability goals
19 at the neighborhood scale, especially within urban villages as defined in the 2005
20 Comprehensive Plan; and

21 WHEREAS, the Capitol Hill EcoDistrict represents the broad interests of stakeholders
22 reflected in the diverse membership of the Capitol Hill EcoDistrict Steering Committee;
23 and

24 WHEREAS, the Capitol Hill Housing Improvement Program ("Capitol Hill Housing") is an
25 institutional partner to the City, uniquely qualified to lead this work as a public
26 corporation with an area of operation focused on Seattle's Capitol Hill community; and
27 is tasked with assisting homeowners, property owners, residential tenants, and
residents of the Capitol Hill Community in preserving, improving, and restoring the
quality of their homes, property, and neighborhood; and to provide additional housing,
cultural, social, and economic opportunities and facilities; and



1 WHEREAS, the active collaboration of City Departments in pursuing the goals of the
EcoDistrict is essential to its success; and

2 WHEREAS, the Seattle City Council directed \$45,000 in 2014 to the Office of Sustainability and
3 Environment for contracting with Capitol Hill Housing to advance the work of the
4 Capitol Hill EcoDistrict; NOW, THEREFORE,

5 **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEATTLE, THE**
6 **MAYOR CONCURRING, THAT:**

8 Section 1. City departments are encouraged to recognize the Capitol Hill EcoDistrict and
9 its intersection with departmental work including, but not limited to, the Office of Sustainability
10 and Environment, the Department of Neighborhoods, the Office of Arts and Culture, the Office
11 of Economic Development, the Office of Housing, the Department of Parks and Recreation, the
12 Department of Planning and Development, Seattle City Light, the Seattle Department of
13 Transportation, and Seattle Public Utilities.

14 Section 2. City departments are encouraged to review and provide feedback on
15 EcoDistrict performance targets and provide access to available City data and analysis for
16 tracking EcoDistrict performance targets.

17 Section 3. City departments are encouraged to explore tools and incentives that may
18 advance the Capitol Hill EcoDistrict and remove identified regulatory barriers that thwart
19 EcoDistrict initiatives in the context of the City's broader sustainability and neighborhood
20 development goals.








