## 1. BILL SUMMARY

1. **Legislation Title:** AN ORDINANCE relating to parking; defining "blockface;" updating the definition of "parking payment device;" defining "pay-to-park signage;" allowing the Traffic Engineer to establish areas where parking is regulated by pay-to-park signage and to authorize additional methods of payment for parking; amending the description of certain parking penalties; amending parking and payment requirements; making technical changes; amending Sections 11.14.425, 11.16.300, 11.31.121, 11.76.005, 11.76.015, 11.76.020, and 11.76.040 of the Seattle Municipal Code; adding new Sections 11.14.062 and 11.14.438 to the Seattle Municipal Code; and repealing Section 11.76.010 of the Seattle Municipal Code.

## 2. Summary and background of the Legislation:

The Seattle Department of Transportation (SDOT) began replacing single head, coin-only parking meters with multi-space pay station kiosks in 2004. At that time, the Seattle Municipal Code required a number of updates in response to the new technology. SDOT later updated the Code to include "pay by phone" as an option for payment, and by implementing that new technology, improved the customer parking experience. SDOT recently completed the replacement of its aging pay stations with new pay stations and technology. The advancements in parking technology and payment methodology require another set of minor updates to the Seattle Municipal Code to reflect the way parking operates now, and which pave the way for how it will operate in the future. The proposed legislation:

- Changes the requirement for payment for parking a vehicle from presence of a payment device on the blockface to presence of signage on the blockface;
- Broadens the definition of parking payment devices and allows the SDOT Traffic Engineer to approve new methods of payment in the future, such as in-car payment applications;
- Allows for additional parking payment methodologies to be employed, including paying by license plate, in addition to the current pay and display and pay by phone methods;
- Requires parkers to provide information such as a parking space number or license plate number; and
- Removes outdated language related to old meters and changes references from "space" to "blockface" as we no longer have spaces defined by meters.
