1. BILL SUMMARY

1. **Legislation Title:** A RESOLUTION opposing a proposed liquefied natural gas facility in Tacoma, and urging the Puget Sound Clean Air Agency to reject its permit application.
2. **Summary and background of the Legislation:** This is a resolution opposing a proposed liquefied natural gas facility in Tacoma, and urging the Puget Sound Clean Air Agency to reject its permit application. Puget Sound Energy (PSE), a for-profit company, has proposed and begun constructing a liquefied natural gas (LNG) facility at the Port of Tacoma in the Tacoma Tideflats for the purpose of producing, storing, and distributing liquefied natural gas. Natural gas, like other fossil fuels, emits carbon dioxide, a greenhouse gas that contributes to climate change when used as a fuel source, and leaks along the natural gas supply chain emit methane, a gas with 86 times the global warming potential of carbon dioxide, according to the Intergovernmental Panel on Climate Change.

PSE began construction of the LNG facility without first obtaining the necessary approval by the Puget Sound Clean Air Agency (PSCAA), resulting in issuance of a Notice of Violation, number 3-008343, by the PSCAA in April 2017. The PSCAA is currently considering PSE's application for a permit to build and operate the LNG plant in Tacoma, and Seattle Mayor Jenny Durkan, represented by the Office of Sustainability and Environment, holds a seat on the Board of Directors of the PSCAA.
