1. BILL SUMMARY

Legislation Title: A RESOLUTION providing an honorary designation of 22nd Avenue NW between NW 56th and NW 57th Streets as "Rob Mattson Way."

Summary and background of the Legislation:

The Seattle Department of Transportation will manufacture, install, and maintain honorary signs at the intersections of 22nd Avenue NW between NW 56th and NW 57th Streets, which shall reflect the "Rob Mattson Way" honorary designation. Rob Mattson, who passed away in 2018, started his 42-year career with the City of Seattle in 1971. In 1973, Mayor Wes Uhlman appointed him as director of the Ballard "Little City Hall." As head of the Ballard Neighborhood Service Center and founder of the Ballard District Council, Rob continued his work connecting residents of Ballard with each other and with City services through most of his career, until his retirement in 2013. In later years of his career, Rob was often referred to as the Mayor of Ballard. By introducing this resolution, Mayor Durkan, along with his family and friends, intend to honor Rob with this honorary street name designation.
