1. BILL SUMMARY

Legislation Title: A RESOLUTION relating to a Green New Deal for Seattle; establishing goals, identifying actions necessary to meet these goals, affirming the federal Green New Deal resolution, and calling for the federal government to enact policies to advance a Green New Deal.

Summary and background of the Legislation: In early 2019, the United State Congress considered a resolution calling for a Green New Deal, which proposed that the federal government make major investments in programs and establish policies that would address climate change and economic inequality. This legislation calls on the U.S. Congress to enact Green New Deal policies and would establish a vision and goals for a Green New Deal for Seattle, identifying key strategies needed to achieve these goals. Specifically, the resolution identifies actions in the following areas:

- Building efficiency
- Transportation
- Housing affordability
- Renewable energy
- Climate preparedness and emergency management
- Job training

The work described in the resolution is generally ongoing work that is part of the mission of the departments identified. However, implementing the resolution may require that departments reassess or reprioritize their work programs and could result in the need for additional resources as project scopes become better defined.

Failing to take action on the work described in the resolution would likely result in Seattle not achieving its goals for reducing greenhouse gas emissions, further accelerating the rate of global warming and the risks associated with climate change.
