1. BILL SUMMARY

Legislation Title: A RESOLUTION requesting the Seattle Department of Transportation develop a budget proposal for creating on-street bike and e-scooter parking.

Summary and background of the Legislation: As multi-modal share programs expand and more commuters turn to bikes and scooters to navigate Seattle, the City must maintain and expand our multi-modal parking infrastructure. The current bike share program has also caused cluttering on our sidewalks making them increasingly difficult to navigate, particularly for people with disabilities. At intersections where car parking is already illegal, we should continue building in-street biking corrals to encourage off-sidewalk multimodal parking. While the Seattle Department of Transportation is on track to complete the goal of adding nearly 1500 bike parking spots throughout the city in 2019, we must continue to invest in and expand the multimodal parking infrastructure. This legislation calls on SDOT to develop a budget proposal to fund the expansion of the on-street bike and scooter parking corrals for 2020.
